## ICARES members participate in simulated emergency test

Ionia County Amateurs Radio Operators (HAMS) met for a scheduled breakfast in Ionia on Oct. 3. A small group discussed the problems of a countrywide emergency requiring HAMS were ready to test a new repeater and antenna recently installed on Tricounty Electric tower in Portland. The Lansing Civil Defense Repeater Association made the repeater available and donated the antenna to our group. Dan Harger-W8BCI, Don Rickert-W8BQD and Jan Bradfield-KC8BFB converted the commercial equipment to the HAM band. Brent Williams-WB8TRL climbed the Tri-County tower and placed the new antenna at 100 feet on the tower.

Ray Wardwell, Ionia County Amateur Radio coordinator, called the net to order at 9:45am. He passed control of the net to another HAM so he could organize traffic to be passed on the net. Messages going to state, district, counties and Ionia County political unites were listed with the net. HAMS called in to indicate traffic they could accept. When the net was closed at 3:00pm, messages for 15 political unites and 36 agencies had been processed by eight net control operators. Messages were delivered in Ionia County by local HAMS and messages outside the county were delivered on state traffic nets for delivery. During the county exercise, Curt Benjamin was the acting net control of the state QMN HAM CW traffic net.

The annual Simulated Emergency Test (SET) allows amateurs to train for net control, traffic handling, mobile operations and state net access requirements. Should the group be called out during an emergency, it can provide temporary communications in and out of the county. It would become cadre to train HAMS volunteers not familiar with procedures. The new repeater performed with complete satisfaction. A one watt hand held with roof mounted antenna worked through the repeater from Lake Odessa, which we have never been able to do.

Ionia County HAMS have been placing in the top 10 in the state in this annual national test of preparedness. The following HAMS from Ionia County Amateur Radio Emergency Service (ICARES) were 'Radio Active' in the test: Curt Benjamin-K8AI; Jim Hamilton-WA8KDP; Dan Holcomb-N8FUF; Donna Burch-W8QOY; John Schafer-N8ZMT; Denise Schafer-KC8FYW and Randy Wardwell-WB8VKL.

## “Doc” Gmelin, W6ZRJ, Dies

Former ARRL Pacific Division Director Jean A. “Doc” Gmelin, W6ZRJ, of Los Osos, California, died February 11, 1999. He was 71. An ARRL Honorary Vice President, Gmelin, was Pacific Division Director from 1968 until 1978. He also had served as an assistant Pacific Division director, as Santa Clara Valley Section Communications Manager, and as an Assistant Section Manager for public service and external relations in Santa Barbara.

First licensed in 1947, Doc was a past officer of the Santa Clara Valley Amateur Radio Association, the Merced Amateur Radio Association, and the Northern California Traffic Association. He was active in the Southern California CW Net. He was a member of the A1 Operators Club and had been active in RACES.

He was a Life Member of the ARRL and a member of QCWA, as well as a QST author and a Worldradio magazine columnist. A graduate of San Jose State University, he served in the Naval Reserve and later worked for several San Jose-area newspapers as a photographer. Later, he taught electronics and math and was audio-visual coordinator at a high school in Sunnyvale, California. He also was an avid duck hunter.

Pacific Director Brad Wyatt, K6WR, reports that a combined Amateur Radio and Masonic memorial service will be held Sunday, February 14, 2 PM PST, at the Los Gatos Memorial Cemetery, Los Gatos-Almaden Road, Los Gatos, California.

Gmelin's wife, Caroline, K6BGM, is among his survivors.

## PSK31 GETS RAVES

Getting tired of the “same ol’ same ol’” on HF? From the father of AMTOR, Peter Martinez, G3PLX, comes PSK31, a “live QSO” keyboard-to-keyboard mode that occupies a sliver of bandwidth and offers terrific performance even under weak-signal conditions.

PSK31 isn’t new; it’s been around for a few years, but no one really took much notice until Martinez developed free software that works with a PC sound card. Suddenly, PSK31 has become the latest HF fad. Unlike ‘TOR modes, PSK31 does not use a synchronized linking—or handshaking—protocol to exchange error-checked data packets. Operationally, it’s much like traditional 45-baud RTTY. PSK31 has shown itself to be a real trouper in weak-signal situations. Some hams experimenting with PSK31 claim that it outperforms all other amateur modes for weak-signal work—including CW. Indeed, PSK31 signals are easy to overlook on the bands. Most PSK31 activity is concentrated on 14.070.15 and at 3.580.15 MHz. You’ll also find it on 40 meters at 7.035.15 MHz. On 15 meters, look for activity around 21.070 MHz.

To run PSK31, you need a PC that runs Windows that’s equipped with a sound card. PSK31 software is available via the Web). Your HF SSB transceiver should be very stable and tune in 1-Hz increments. The connections between the radio and the sound card are very straightforward.

Several versions of PSK31 software are available as zipped files. The latest PSK31 software includes a couple of tuning aids that make finding and tuning signals much simpler. The “official” PSK31 Web site is <http://aintel.bi.edu.es/psk31.html>, operated by Eduardo Jacob, EA2BAJ. The site also contains lots of information and links to other PSK31 and DSP-related sites, plus .wav files of PSK31 signals, so you’ll know what to listen for.

W1AW Station Manager Joe Carcia, NJ1Q, has experimented with the new operating mode, PSK31, at the Maxim Memorial Station. While it took a bit of effort to get the equipment to function properly, he says initial results were quite good. Plans are in the works to add this mode to the complement of modes available for W1AW visiting operators.

Some have questioned whether the FCC permits hams to use PSK31. The answer is a definite “yes,” although some confusion is understandable given the wording of Section 97.309(a) of the rules. Responding to an ARRL inquiry, the FCC amended the section in 1995 (Order DA 95-2106) “to clarify that amateur stations may use any digital code that has its technical characteristics publicly documented.” PSK31 is publicly documented and widely available, but the ARRL in late January took the additional step of specifically documenting the technical characteristics of both PACTOR II and PSK31 in a letter to the FCC.

## King Hussein, JY1, Dies

Radio amateurs around the world joined in mourning the death over the weekend of Jordan’s King Hussein, JY1. Hussein, 63, died Sunday morning. The Middle East’s longest-reigning ruler, he’d been Jordan’s king for 47 years, taking the throne when he was just a teenager. His son, Abdullah, 37, succeeds him.

Hussein had earned a reputation as a catalyst for peace and as a conciliator in the Middle East. President Clinton is among the heads of state from around the globe gathered in Jordan today for King Hussein’s funeral.

Hussein was a life member of the ARRL. ARRL Executive Vice President David Sumner, K1ZZ, called him “an enthusiastic radio amateur whose support was invaluable to us in obtaining new amateur bands at the 1979 World Administrative Radio Conference.” Sumner recalled that in May 1979, International Amateur Radio Union President Noel Eaton, VE3CJ, was invited to Amman to meet with King Hussein.

“Jordan’s support of the Amateur Service was much in evidence at the conference that fall, and was a crucial element in our success,” Sumner said. The WARC-79 resulted in Amateur Radio’s gaining the 30, 17, and 12-meter bands. That same year, JY1 was featured in the film, “The World of Amateur Radio.” Hussein regarded his 1983 contact with Owen Garriott, W5LFL, on board the Space Shuttle Columbia, as a high point in his Amateur Radio activity.

King Hussein also participated in the historic 1995 joint Israel-Jordan JY74X operation on Mt Nebo, where hams from both countries participated in a Field Day-like operation. The King put

in appearances both on the air and in person, much to the delight of the participants and those waiting to work him and JY74X. Hussein’s friend Bruce “Blackie” Blackburn, W4TA/JY9BB, of St Petersburg, Florida, called him “one of the world’s most respected amateurs” and recounted many stories about King Hussein as a person and an avid Amateur Radio operator. “He was a wonderful guy, interested in everything and everyone,” he said.

Blackburn said King Hussein “promoted Amateur Radio to the hilt in Jordan” and saw to it that Amateur Radio classes were

instituted in elementary schools. King Hussein also dropped in on meetings of the Royal Jordan Radio Amateur Society in Amman. King Hussein also was involved with the early satellite experiments.

Hussein had been active in recent months from the US while seeking cancer treatment at Minnesota's Mayo Clinic. A QSO with JY1 was considered by many hams to be both an honor and a privilege. His elegant QSL card was prized. AMSAT Area Coordinator Bruce Paige,

KK5DO, in Houston, worked JY1 while the king was in the US last summer. "That was a very exciting moment for me," he said.

Pat Kilroy, WD8LAQ, says he enjoyed a three-minute contact on 20 meters with King Hussein in the fall of 1995. "JY1 was traveling aeronautical mobile, enroute to the United Nations. He insisted on me addressing him simply as 'Hussein'," he said. "In one of the oldest traditions in Amateur Radio, Hussein upheld that this kinship transverses not only age and nationality, but also between citizen and head of state.

All members of the Jordanian royal family automatically have Amateur Radio privileges in Jordan. Although the new king does not appear to have a call sign, King Hussein's widow—the American-born Queen Noor—is JY1NH. King Hussein's brother, the former Crown Prince

Just think, if this toaster had been made with vacuum tubes it would take up my entire kitchen. The heat of the tubes alone could do the toasting.



## CMARC SPECIAL BOARD MEETING

Jan. 16, 1999

Because CMARC's Board and regular January 8th meeting was cancelled due to expected snow accumulations and bitter wind chills, a "Special" Board meeting was called to discuss issues pertaining to the upcoming year. The meeting was held at the Delhi Café in Holt, and Pres. Erv/W8ERV brought the meeting to order at 2:15 p.m. with all Board members present. They were Pres. Erv/W8ERV, V. Pres. John/N8LLC, Treas. Bill/KB8TTS, Sec. Julie/KB8ZXR, Dir. Don/KB8RAD, Dir. Joe/N8VYS, and Under 22 Dir. Judd/KC8IRG. Judd's Father, Paul Gundersen, was invited to sit in on the meeting and made several welcomed suggestions. Also attending our Special meeting were two of the three members of the new Financial Committee: Dennis/KB8ZQZ and Don/W8BQD (along with his wife Hazel/K8KSX). The third member of the new Committee, Forrest/N8PWD, was out of town and excused.

Erv briefly outlined the role of the new Financial Committee, which was "voted in" at the November '98 meeting, and described how they will be paying close attention to

CMARC's credits and debits. Erv said that the regular yearly donations to the Red Cross and the Boy Scouts would be given without Committee approval, and explained that only "extra" donations or "unexpected" expenditures would be directed to the Committee for their approval. Don/KB8RAD made a motion that since we now have a Financial Committee, we should start the practice of having the books audited at the end of each year. It was seconded by Bill/KB8TTS and approved by all.

Erv then related to us some of the ideas he has for bringing money into the Club's treasury, such as holding car washes, Rock-a-thons, and Bike or Walk-a-thons. He said we could get the younger members involved with these events and the money made would not only go into the General Fund, but could also be used to allow the younger Hams to take field trips. He said the field trip idea might be a good way of enticing more kids to join the Club. SCIENCE DAY @ THE MALL: Joe told the Board he had received an application for us to participate in the 9th Annual Science Day @ the Mall. It will be held on Sat., Feb. 6 from 11 a.m. to 4 p.m. at the Meridian Mall in Okemos, with set-up from 9 - 11 a.m. A motion was made by Julie/KB8ZXR to participate in the Science Fair. It was seconded by Bill/

KB8TTS and approved by all. Joe said he and Pam/KB8PSF would be willing to oversee the project and make sure everything was taken care of. A check for \$30 was written for the rental of two tables. Each table comes with a cover, skirt, and 2 chairs. The Sec. will fill out the application, requesting electricity, and mail it as soon as possible.

HAM FAIR: Some of the topics we discussed are: (1.) LOCATION - We discussed the pros and cons of staying at the Fairgrounds. The pros - Don/WB8NUS said that Ingham County Fairgrounds lowered their rental by \$100, instead of raising it \$50, which we were told would happen. The cons - the Board has received many complaints regarding the difficulty in negotiating the tight isles at the Fairgrounds Community building, and were told by some that they wouldn't be back because of it! A suggestion to take out a row of tables and rearrange the room for more space was made, and will be relayed to Don/WB8NUS, who does the floor plan. Another thing to think about is the fact that there will be a wedding reception the night before and we will, once again, have to clean up after it. This means extra work for the kitchen crew, because they have to clean the kitchen before they

can even start to wash their own cooking utensils and then begin cooking.

Bill/KB8TTS, who is famous for attending just about every Swap there is, also expressed his concern of trying to improve our Ham Fair. He said he knew all the Swaps have been down in attendance the last few years but feels ours has suffered the most. He said he has also heard many complaints about the size of the bldg. and was also told, "we WON'T be back again this year". He urged us to do something to turn things around and said he feared if we don't act now, we eventually won't have a Swap at all. Someone then asked if a decision had been made against holding the Swap at the Alaiedon Elementary School. Erv replied that CMARC's membership had voted to go with Alaiedon, but when it was brought before LCDRA's membership (with the new information that the Fairgrounds was lowering the rental by \$100), even though LCDRA thought the new location was better, they voted to stay at the Fairgrounds. CMARC's Board then decided they would like to take the risk and spend a little more and maybe not make a profit this year, and go with Alaiedon. A motion was made by Bill/KB8TTS to talk with LCDRA and re-locate our Swap to Alaiedon. It was seconded by John/N8LLC and approved. The Board then asked Erv to talk with LCDRA's President again about relocating to Alaiedon Elementary School, and re-voting on the location at LCDRA's Feb. 18th meeting.

(2.) TIME OF THE SWAP: There have been complaints that we close too early in the afternoon and people who go to church get there as we're shutting the doors. We can't change the day because of other Swaps and the Dealers are booked, so a suggestion was made to add an hour. A motion was then made by Bill/KB8TTS to go from 8 a.m. to 2 p.m. It was seconded by Joe/N8VYS and approved.

(3.) FLYERS: One suggestion was to have about 1,000 flyers printed in February or March, so CMARC members could leave them at Swaps they attend during the year. Some suggestions for things that needed to be included on the flyer were: (A.) Listing the Swap as a "Ham Fair/Computer Show". (B.) Include a detailed map. (C.) Have a complete address along with phone number and possibly an e-mail address for the contact person (Don Tillitson/WB8NUS). (D.) Show the Club and ARRL logos. (E.) Tell what prizes we are giving out. (F.) Tell how many years we have been having the Swap. (G.) Advertise that we are having a DX Forum, VE testing, QRP, etc. (H.) Advertise that we are bringing in radio equipment and will be doing some

DX'ing, and then inviting the public to come in to experience a fun Hobby!

(4.) ADVERTISING: It was suggested that we do more advertising. Some places we could advertise are: in Ham magazines (QST, Nuts & Volts, Amateur Radio Trader); Public Service announcements on Radio, TV, and in the Shoppers Guide; and put flyers on the community billboard inside the Meijer's doorways, GM, and Fulton Radio. Another suggestion was that we send a flyer along with two free admission tickets for our Swap to a few other Clubs, like Jackson, Adrian, Shiawassee and Ft. Wayne.

(5.) SIGNS: It was suggested that we have more signs than we have had in the past, and that they be large and sturdy enough to be read as you are driving by (not just a flimsy piece of paper with an arrow on it that can be blown around in the wind). The signs at the freeway exits and roadway should be clearly viewable so as to direct someone unfamiliar with the area to the Swap. Another suggestion was that they be laminated so they can be reused next year.

(6.) PRIZES: It was suggested that we purchase a nice raffle prize like an HT and advertise it on the flyer. Don/KB8RAD said that we should shop around in the months before the Swap and buy an HT on sale to be used for a prize. Bill/KB8TTS said he could buy a Standard or Midland through his suppliers at wholesale cost for us. It was proposed that we buy both an HT and a mobile. The mobile could be given as the grand door prize, for which you would have to be there to win! John/N8LLC suggested contacting a computer business that might donate a small computer in exchange for advertising in the Scope. Erv asked that we table this discussion till the February Ham Fair meeting.

(7.) DEALERS: It was suggested that we contact a few computer places like Sky Tech and some others right away so we can get them ahead of time.

(8.) UNDER 22 TABLE: It was suggested that we have a table with Ham literature (Scouting, ARRL, etc.) for the under 22 age group at the Swap. Judd/KC8IRG will contact ARRL for comic books and other info and will be in charge of the table. He will ask Samuel/KC8HGG if he would be interested in helping.

(9.) MAKE IT FUN! : It was stressed by all that we make attending our Swap a "fun" experience, and make it especially inviting for even non-Hams! It was hoped that, with the earlier suggestion of bringing in equipment for on-sight DX'ing, even the non-Ham public could see how fun our Hobby really is.

MEMBERSHIP DRIVE: Erv mentioned how he had gone through the SAM data base of

licensed Amateurs, in just the city of Lansing, and said he couldn't believe how many names he hadn't recognized and knew had never visited the Club. He suggested it might be nice to send them a postcard or a flyer telling about CMARC and LCDRA, and inviting them to visit. (The Sec. said Bob/W9NIP had sent her a list of names a few years ago with the same idea. She said the Board had voted at that time to send out a mailing, but with subsequent deaths and resignations on the Board, the ball got dropped.) We then discussed the idea and agreed that it sounded like a good venture to pursue. John/N8LLC suggested that we hold off long enough so he could try to find the e-mail addresses for some of the Amateurs on the list, which would save us a lot of money.

Joe said it would be nice to get our own members to regularly attend the meetings. He added that one reason they didn't was because we don't have programs that interest them. He made a suggestion that we do more to plan "special" programs like we had done in the past, and then announce in the Scope (in advance) who our speakers will be, like we used to. He also said that we should get more involved with DX'peditions and contesting, and in making more use of our Club station.

AMATEUR RADIO CLASSES: Paul Gundersen (Judd/KC8IRG's Father) suggested having Amateur Radio classes. He said that in Arizona, where they are from, they had Ham classes that coincided with the local school year. He said that was how Judd got his license, along with several of Judd's friends. Erv said he had heard that Shiawassee and Livingston Counties were once again holding classes, and commented on how they always had such a large turnout. The Board thought it was a good idea and after a discussion, Don/W8BQD volunteered to be the Chairman for getting classes started in our area. Dennis/KB8ZQZ, who is also a member of the MSU Amateur Club, said he knew that MSU had expressed an interest in classes and that he would check with them to see if they would be willing to work with us in the venture. Joe made a motion to contact the ARRL for training materials and information on holding classes. The motion was seconded by Erv and approved by all. Erv also suggested contacting Ray/N8CPO from the L.A.R.K. group in Howell, and asking them what their curriculum is, how long they hold the classes, and if they teach code. Dennis said he would contact both the ARRL and Ray for the necessary information.

Julie/KB8ZXR made a motion to adjourn the Special Board Meeting. It was seconded by John/N8LLC and approved. We adjourned at

3:40 p.m.

## CMARC BOARD MEETING February 5, 1999

President Erv-W8ERV brought the meeting to order at 7:35 p.m. All Board members were present, with Don-WB8NUS and Dennis-KB8ZQZ also in attendance.

Erv told the Board that Bill-KB8TTS had talked to him and the Secretary, earlier in the week, about giving up the position of Treasurer. Bill said that because of "time" constraints (what with running his own business and all), he just didn't have the time to do the job of Treasurer the way he wanted to. He said that if (because of his current circumstances) he could not give his utmost to the Treasurer position and do the job the way he thinks it should be done, then he would rather have someone else take the job this year. He would still like to remain on the Board as a Director, however. Since Joe-N8VYS had said at the December meeting that he would stay on as Treasurer if no one else wanted the job, the Secretary called him after her conversation with Bill and asked him if he would still be willing to do it. Joe graciously agreed and said he would get the books from Bill at February's meeting. Since only a Board vote was needed at tonight's meeting to make a change in their Directorships, Don-KB8RAD made a motion that we make Joe the Treasurer and Bill a Director. It was seconded by John-N8LLC and approved.

He has tapes and manuals for the Technician Class license, along with other materials. He will give an update at the regular meeting tonight. The Board is hopeful of having classes started some time between March and April. Don-WB8NUS said Target Stores will be giving out "A Million Hearts" Valentine's Day ballots that give Target shoppers the right to vote for their favorite charity. A million dollars will be donated by Target to be divided between five charities depending on the percentage of ballots per organization. The balloting will be held from February 7th - 13th and it would be nice to show our support for the Red Cross by voting for them at that time. A motion was made by John-N8LLC to adjourn. It was seconded by Joe-N8VYS and approved. The meeting adjourned at 7:59 p.m. Julie McLain-KB8ZXR-Secretary

NEW BUSINESS: Erv told the membership some things that the Board discussed at their Special Board Meeting of Jan. 16th. (Please refer to those minutes and tonight's Board minutes for complete details.) One of the many

things the Board is working on is Amateur Radio Classes. Dennis/KB8ZQZ, who is working with Don/W8BQD in getting the project started, gave an update on what they have accomplished since the Jan. 16th meeting. Dennis contacted the ARRL and received a video course and instructor's manual, etc. for the classes. He talked to John/AA8LF who is willing to teach 3 weeks of CW. Dennis also contacted the MSU Club about participating in operating the classes. He said a member of their Club was willing to help teach, and the Faculty Advisor (Dr. Michael Shanblatt/K8MAS) was willing to do the lesson planning and a fair amount of teaching himself. They would like some additional people to teach some of the materials. Dr. Shanblatt said he thought there was a room in the Engineering Bldg. on campus we could use along with any AV equipment that will be needed. A date and time haven't been decided on as yet, but it was felt that a Saturday would probably work best at MSU, and parking then would not be a problem either. 



At the February meeting, we were treated to a visit and presentation by Great Lakes Division Vice Director George Race/WB8BGY. George had an information-packed hour long chat with CMARC members where he outlined many of the coming events for 1999.

One of the most notable items was the statement by Race that he expected to see a decision on license restructuring reached and announced by or maybe even at the 1999 Dayton Hamvention. With all formal and informal comments to be completed, this is a pretty educated guess. Race cited the FCC and the League's penchant for "timing" such announcements at Dayton. This could be excellent news for Technician Plus, as well as Advanced licensees, since they stand to gain the most from this decision.

Vice Director Race also took time to cover the latest round of FCC activity in enforcement of Part 97 Rules. He spoke of the FCC's new "Top Gun" in enforcement, Riley Hollingsworth/K4ZDH showing up on 75 meters in mid January, the "surprise" station inspections in the Carolinas and offered an email address, as well as a phone number to reach Hollingsworth with your own reports of abuse. To contact Riley, you can send email to: rholling@fcc.gov, or call him at (717) 338-2502. For this Ham, it's about time and we support him 120% in his efforts to make our Hobby a little more like it used to be. And one more aside, Hollingsworth is NOT limiting his efforts to HF.....word of some action in the VHF bands has reached us, too!

A little more good news came from Race, with word of a "small gift" from the ARRL. For those ARRL members with online services, you may now have a FREE email redirector. All you have to do is register on the League's "Members Only" Web Site (URL found in QST) and you will have (your call)@arrl.net, which will send all email directly to your primary account. What this means, for those who (of necessity) need to change Internet Service Providers, you can do so and keep the same email address from now on. For all the details, visit the Site today.

Vice Director Race mentioned that the ARRL may soon bear a new name. An executive committee is in place to consider such a change and they want your input. A similar plan was abandoned in January, 1993. We'll know more in July of this year, but drop them a line and express your view.

And one final development from the February meeting, George had the unfortunate task of announcing (unofficially) the "clinical" death of Jordan's King Hussein/JY1. As we know now, the cancer-stricken monarch died Sunday of that week, but was on life support prior to that.






