K1LNC NAMED AS INTERNATIONAL HUMANITARIAN AWARD WINNER

The ARRL has named Edwin Petzolt, K1LNC, of Hobe Sound, Florida, as the winner of its 1999 International Humanitarian Award. A presentation was made earlier this month at the Miami Tropical Hamboree by ARRL President Jim Haynie, W5JBP, and ARRL Southeastern Division Director Frank Butler, W4RH.

On June 29, 1998, Petzolt responded to an on-the-air emergency call on 20 meters and found himself on the other end of a life-threatening situation in Central America where heavily armed gunmen had kidnapped four missionaries in northern Guatemala and held them for ransom. Desperate to save his family, missionary Elam Stolfus, TG7XQS, turned to ham radio—his only connection to the outside world. On the other end he found Ed Petzolt, K1LNC.

Upon learning of the family's plight, Petzolt, phone-patched Stolfus to the US Embassy in Guatemala City to arrange for military and police assistance. He then remained at the radio for much of the next seven hours to provide communications and relay information that would contribute to the successful rescue of the hostages and the capture of the terrorists.

The ARRL International Humanitarian Award recognizes extraordinary service through Amateur Radio skills for the benefit of others in times of crisis or disaster. The award recipient is selected by a committee appointed by the League's President. Petzolt's award was confirmed by the ARRL Board of Directors during its meeting last month in Memphis.

An ARRL Life Member, Petzolt credited Bud Palmer, KC4LCD, Tim Reeves, WB4WUK, and "everyone else who helped keep the frequency clear," with making the rescue mission possible. The story of Petzolt's efforts is detailed in "Guatemala Rescue!" in The ARRLWeb Extra for September 1, 1998, on the ARRLWeb Members Only site, http://www.arrl.org/members-only/extra/features/1998/0901/1/index.html

A footnote: Petzolt this week became involved in another Amateur Radio rescue mission: "I patched a doctor from Honduras to a doctor in Pennsylvania this morning regarding a nine-month-old little girl with a life-threatening, congenital heart condition," he reported February 17. Petzolt said the US doctor agreed to perform the surgery in Pennsylvania for free. He then patched the ham-Ronaldo Roll, HR3RON, a Catholic priest—into the US Embassy in Tegucigalpa to arrange to expedite the necessary paperwork for the infant and her mother to get a medical visa. Petzolt said Roll has agreed to pay their airfare to and from the US. "I think I found my calling in life," Petzolt remarked.

FCC FINES TWO TEXAS AMATEURS FOR MALICIOUS INTERFERENCE

The FCC has fined two Texas hams \$8000 apiece for allegedly interfering with a local repeater and failing to identify. Paul E. Holcombe, K4TOF, and Robert L. Myers, N5WLY, both of Houston, were notified last month by the FCC's Houston office. The fines come in the aftermath of an FCC investigation undertaken last year that involved the use of direction-finding equipment. The FCC says it's been hearing complaints of interference to the Memorial Emergency Repeater Association's system for more than five years now.

On separate occasions in February and May, FCC personnel from the Houston field office used direction-finding gear to track transmissions interfering with MERA's 145.47 repeater to Holcombe's and Meyers' vehicles. As a result,

Holcombe and Meyers each received a Notice of Violation from the FCC last June. Since being cited, both men have denied the allegations in statements to the FCC.

In both cases, the FCC determined otherwise and ordered Holcombe and Meyers to pay the fines within 30 days or to file written statements showing why the forfeitures should be reduced or canceled.

FCC AFFIRMS \$20,000 FINE; UNLICENSED OPERATION CONTINUES

The FCC has affirmed a \$20,000 fine levied on a Florida man last summer for unlicensed operation, willful and malicious interference with Amateur Radio communications, and failure to let the FCC inspect his radio equipment. The FCC's January 28 Forfeiture Order gives William Flippo of Jupiter 30 days to pay up or the matter will be referred to the US Attorney.

Following an FCC Warning Notice, Flippo initially was notified of the fine last July in an FCC Notice of Apparent Liability. Hams in Florida say Flippo has thumbed his nose at the FCC and has continued to flout the law by interfering with local HF and repeater nets. FCC personnel from the FCC's Tampa District Office have followed up on complaints from amateurs that Flippo-also known by his CB handle of "Rabbit Ears"-has regularly interfered with hams on 10 meters, 2 meters and elsewhere. The Order acknowledges that the Commission has received information on "at least five occasions" since the fine was levied last July indicating that Flippo continues to violate federal law.

Flippo's only response to last year's Notice of Apparent Liability was to send the FCC a copy of a one-page bankruptcy filing. The FCC was not impressed, however. "In a case where an NAL has been issued and the recipient continues to engage in the same conduct, we are not in-

clined to adjust the forfeiture amount, even where the recipient has filed for bank-ruptcy protection," the Commission said. One Jupiter-area ham who has cooperated with the FCC investigation says Flippo has been causing problems for the amateur community in his area since late 1997. He and fellow members of the Jupiter-Tequesta Repeater Group want to see the FCC take a stronger stand in the case.

"I want to see the guy in jail—plain and simple—and his equipment confiscated," said the amateur, who did not want to be identified by name fearing retaliation. "The problem is, we're all playing by the rules here, and this guy goes out and buys a radio and he gets on there and does whatever he wants and brags about it."

FCC personnel from the Tampa office have visited the Jupiter area at least twice last year as a result of amateur complaints alleging malicious interference from Flippo, primarily on VHF but also on some HF amateur bands.

ARRL BOARD BACKS CERTIFICATION PROGRAM

The ARRL Board of Directors has approved the development and implementation of an initiative to promote self-education by radio amateurs. The new ARRL Certification Program will aim to inspire amateurs to continue acquiring technical knowledge and operating expertise beyond that required to become licensed and give them a chance to test their own limits. Following up on the "2010 Vision" discussions at last July's Board meeting, ARRL Executive Vice President David Sumner, K1ZZ, presented the broad strokes of the Certification Program during the Board's January 21-22 meeting in Memphis.

At this point, the Certification Program only exists as a concept, with the details to be worked out, but plans call for having the program in place by later this year. The first step in putting the program in

place will be to solicit the ideas of ARRL members, via a Web-based message board, on appropriate topics to be included in the initial rollout. "The idea is to make this program what members want it to be, and not something imposed from 'on high,'" Sumner said.

"Many ARRL members believe there is a widening gap between what the FCC requires amateur licensees to know and what it takes to be truly knowledgeable about Amateur Radio," he continued. "Whether or not you agree, it's certainly true that those of us who took our FCC exams years ago have never had to demonstrate an understanding of current technology. We could use a new challenge." The new Certification Program will offer participants an opportunity to earn credentials at various levels of depth and difficulty in different courses of study-perhaps in such areas as ionospheric propagation, receiver design, and Morse code proficiency. Sumner said the ARRL should and will continue to encourage the development of Morse code proficiency beyond the basic HF licensing requirements. He observed that the standards for ARRL certification could be more stringent and more uniform than those used for FCC exams.

Sumner said he sees the certification program not only as a welcome opportunity for individual self-development but a response to the perceived "dumbing down" of Amateur Radio qualifications—especially in the aftermath of the FCC's recently announced license restructuring plan. While the plan was not developed directly in response to restructuring, its timing could not be better, Sumner said, conceding that the restructuring debate "has moved it up the agenda."

As envisioned, the program would be largely self-supporting, but startup costs would be funded from the Exceptional Merit Stipend established by the late Ethel Smith, K4LMB. The Certification Program will be dedicated to her memory. Smith—who helped found the Young Ladies Radio League and served as its first

president—died in 1997, leaving the bulk of her estate to the ARRL.

Sumner says a Web-based message board will be set up in a few weeks to gather input from members in terms of specific programs and areas of study or skills development they would like to see become part of the voluntary certification program. The League plans to seek outside expert input to assist in setting the knowledge or performance threshold at the optimal level.

The program likely will include some professional development aspects and could include the granting of Continuing Education Units—CEUs. The League also is seeking cooperative arrangements with related professional organizations. It already has a memorandum of understanding with the National Association of Radio-Television Engineers and has approached the Society of Broadcast Engineers for a similar agreement.

The voluntary certification program dovetails neatly with goals expressed by the League's new President Jim Haynie, W5JBP. Following his election January 21 in Memphis, Haynie said he favors even greater promotion of Amateur Radio, especially among youth and in schools, as well as programs to rekindle interest and activity among current licensees.

News From Around Town

Including Meeting Minutes from CMARC and LCDRA

CMARC BOARD MEETING

FEBRUARY 4, 2000

President Erv/W8ERV called the Board meeting to order at 7:38 p.m. All Board members were present except for Bill/KB8TTS, who had been excused. Also attending the Board meeting was Dennis Boone/KB8ZQZ, the trustee for LCDRA.

HAM FAIR 2000 Committee volunteers - (1.) Set-up and teardown: Setup will begin at 5 or 6 a.m. At least 10 people are needed for this job. Only John/N8LLC and Tyler/KC8LWG have volunteered, so far. (2.) Publicity & Flyers: Pam/KB8PSF and Erv/ W8ERV. (3.) CMARC/ARRL Table: Julie/KB8ZXR (if she is not needed as a non-VE helper). (4.) VE Testing: Don/ KB8RAD and Joe/N8VYS, so far. (5.) Ticket sales: Four people are needed for this job. They will rotate, with two persons selling tickets at any one time, and they will be working 1-hour shifts (1 hour on, 1 hour off). The first hour that the doors are open, we will have at least three, if not all four persons selling tickets for the rush hour. Everyone will be able to enter the Center to keep warm and dry. However, the doors to the Main arena, where the Ham Fair is held, will be closed until no earlier than 7:50 a.m. These doors to the Main arena are where the entrance tickets will be sold. We will sell tickets to visitors before the Main arena doors open for the Ham Fair, so there won't be a lot of congestion at the Main arena entrance. (6.) Vendor Unloading/loading: Major vendors only will be permitted to drive into the facility for the purpose of unloading and re-loading their merchandise. We do not want to have a lot of exhaust fumes in there for the Fair. (7.)

Ticket Prices: Tickets will be \$5.00, in advance, with an s.a.s.e. (self-addressed stamped envelope), and \$6.00 at the door.

Erv passed around a mock-up of the flyer he has been working on for Ham Fair 2000. He asked for comments on the flyer and a motion to use it as our official Ham Fair flyer. A motion was made by Don/KB8RAD to accept this mock-up. It was seconded by John/N8LLC and approved.

Joint CMARC/MSU Amateur Radio Club Classes: Dennis Boone/KB8ZQZ gave a brief update on the classes being held at MSU. He said that 48 people had registered, and they were expecting quite a big turnout

Fund Raising Ideas: Erv updated us with more details on the idea he brought to the Club in January of the possibility of members selling candy to raise money for different Club events. Erv said Profit Potentials, a company that sells bulk candy for this purpose, told him that the minimum we could start with was 50 cases and that we would make a 50% profit. Our cost for the 50 cases would be \$2,520.00 and we would get 5 bonus cases added to offset our shipping cost. However, we would have only one month to sell the candy. Each candy bar comes with a \$1.00 off certificate for Subway sandwiches. Profit Potentials also told Erv that Wal-mart has a "matching grant" program for non-profit organizations, where you sell your goodies and Wal-mart will match what you sell. Tyler reported that he had checked with his school and was told that since we were not affiliated with the school, we could not sell the candy on the school grounds. He is, however, checking out another possibility and will report back at the March meeting. It was then decided that we would table the candyselling proposal until the March meeting. At that time, we will bring it to the membership to see if it is something they are willing to do, or if we should just forget it all together.

"Return Service Requested" Project: Pam/KB8PSF reported that she had a bunch of Scopes that had been returned by the Post Office. They were returned because they could not be delivered due to wrong addresses, and many were marked "no forwarding address". She then told the Board that she had to pay \$8.00 for the postage due on these Scopes as they were over the oneounce requirement, and therefore, it cost the Club 55 cents for each one that had been returned. (She clarified that the weight was okay for our bulk-mailing permit, but it was just when they came back separately that the weight made a difference.) President Erv said he would take care of these returns.

Pam also asked if Erv or Julie/KB8ZXR (who also have keys to the P.O. box) had picked up any of the Club's mail and especially the yellow postage due slips. They both replied that they had not (it had been decided over a year ago when Joe/N8VYS was Treasurer, that only the Treasurer would go to the P.O. The President and Secretary would have a key so that if needed and asked by the Treasurer, they could get the mail). Pam said that she had received a certified letter from the P.O. saying they had a bunch of postage due slips in the backroom for us. Apparently the Post Office said they only hold these slips up front for ten days and then they put them in the back room. She said some of them were from as far back as December. Pam told them she had been there three times and had taken. and paid for, all the slips that she had found in the box. [Secretary's note: It sounds like it's the Post Office's er-

ror in not putting them in the Club's P.O. box and <u>leaving</u> them there so they can be picked up!

Pam also reported that on the Pollack statement, they were still listing Cary/KC8JKA as the person to ship products to, so she mailed them a request to change their records so that everything would be sent to Erv/W8ERV, since he is the new Scope Editor.

Pam said that the Ham club in Toledo, Ohio had sent us two vouchers that can be redeemed for two tickets for their Ham swap. Erv said we can hand them out tonight to whoever wants them, or use them as a drawing prize.

With the Board's business concluded, a motion was made by Don/KB8RAD to adjourn. It was seconded by Pam and approved. The Board meeting adjourned at 8:05 p.m.

Tetsuya, whose life was full of great accomplishments, is also the one who had done so much in helping meteorologists understand tornados. He is not only credited with the invention of the "F" or "Fujita"scale of tornadic strength, but is also the one who made meteorologists aware of the existence of microbursts, which has drastically improved aviation safety. To help preserve all of his father's research for future generations, Kaz is now working on setting up three archive centers that will have copies of all his manuscripts, maps, pictures, etc. Kaz said that one repository will be located in Texas Tech University's Wind Engineering Research Center in Lubbock, another will be at our very own

Michigan State University, and the third will be at a museum in Japan. Kaz is also working with Colorado State University to possibly have a fourth repository located there.

After his presentation and a brief period for questions and answers, everyone gave Kaz a round of applause. The meeting then adjourned at 10 p.m.


