HamFair2000 Wows Em' at the Summit

HamFair2000 went off like a Fourth of July celebration, complete with a big old fashioned 'bang', on Sunday October 8th, at The Summit in Lansing's Capital Centre.

Making a move of this magnitude gave more than a few people plenty to talk (and worry) about, but in the final analysis, The Summit was just what the doctor ordered. With a crowd estimated at pushing 700, it gave HamFair committee members even more to talk about...and smile about!

Winning one of the major door prizes this year, CMARC's own Irv Graham (KD8PI) came away with a snappy little Alinco DJ 195 2m HT and Fowlerville's Kenneth Ciszewski took home the Kenwood TM G707A dualband mobile. Kenneth came as a shopper for computer gear, but was surprised when CMARC President, Erv showed up at his home with the grand prize.

Swap attendees were treated to an ARRL Forum, featuring MI Section OOC, Dave Sefcik (N8NJE) and the FCC's Jim Bridgewater, as well as another fantastic presentation on DX'ing by Bil (W8EB) and Ron (ND5S). Additionally, an unusually nice amount of quality door prizes caught HamFair-goers' eyes. The mobile and HT were but two of the prizes awarded at the show. Others included TWO \$100 gift certificates from Sky-Tech Computers, a philatelic cover signed by ALL members of the ZL9CI DXpedition on Campbell Island, a beautiful digital clock (donated on behalf of a Silent Keys' estate by Jan (K1ND), the usual ARRL offerings of a repeater directory, Handbook and Antenna Book and subscriptions to Amateur Radio Trader, World Radio and others miscellaneous merchandise.

Table sales were unusually slow through the end of August, giving CMARC President, J. Ervin Bates something to worry about. "We didn't like the trend we were seeing. The usual jitters were compounded by our move to The Summit", he said. "But then, it just took off like a rocket. My wife has grounded me from the phone, because it rang so much that last month."

By the time HamFair opened its doors, some 130 tables had been spoken for, plus a few more that sold the day of the event. Weather forecasters called it the coldest weekend of the season, but attendees didn't notice. Even while waiting for the doors to open, people were allowed inside the main foyer of The Summit, keeping them warm and toasty. Of course, the one mainstay of our swap had been trunk sales, but that was also taken out of the plan and ALL sales were held inside this year. The few who complained were silenced when temperatures dipped into the upper 20's that morning, however and HamFair is likely to remain a completely indoor event from here on, thought indoor trunk-type sales are still welcome.

For long time HamFair vendors such as Barb and Duane from ComDac, HamFair2000 was a treat. "We left the show with not one single HT in stock. Our sales were double the usual', Barb said with a smile. "We'll be back next year!"

HamFair2001 is already in the works, with approval given by LCDRA members at their October 19th meeting. Please plan to attend November 3rd's CMARC meeting, as we will be discussing and voting on our site for 2001 and the Chairman's position. Your voice counts.

News From Around Town

Including Meeting Minutes from CMARC & LCDRA

CMARC BOARD MEETING

October 6, 2000

President Erv/W8ERV brought the meeting to order at 7:15 p.m. We were 15 minutes late in getting the Board meeting started as the President was late, the Treasurer was eating a sandwich for her supper, and the Secretary was making coffee for the meeting, in Jane/ KC8FSK's absence. Those Board members present for the meeting were Vice President Steve/W8CRH, Secretary Julie/KB8ZXR, and Treasurer Pam/ KB8PSF. Both Director Don/ KB8RAD and "Under 22" Director Tyler/KC8LWG were excused because of illness, and no one had heard from Director John/N8LLC, who was also absent. Also sitting in on the Board meeting was Currin Skutt/W8FSZ.

Erv gave us an update on Ham Fair and said, "What a difference a month makes!". He reported that as of today, we already have 130-135 tables reserved for Sunday's Ham Fair, and said that it looks like we are going to top last year's number of tables sold. He also told us that we would be having 4 major Computer dealers, and 3 major Amateur Radio accessory dealers at the Swap.

Erv then updated us on the Digital Voice Recorder (DVR) and said it had been installed on the 145.39, but unfortunately, wasn't working the way we had all expected. Since the DVR had just been purchased (in late September), Dennis/KB8ZQZ (LCDRA's Repeater Trustee) did not have adequate time to read up on, and become acquainted with, all it could do. He and Jim/KA8DDQ did have it up and running as requested by the Ham Fair Chairman, Bill/KB8TTS,

however, there were a couple of bugs that couldn't be worked out at this late date. They were: the Ham Fair announcement was made only every 3 hours instead of every hour; the muddled audio; and the 100 cycle tone (an already ongoing and constant source of irritation) which is heard below the signal, interfered with us being able to control the DVR with an HT, thus making it mandatory for someone to actually go to the site to make any changes. Erv said that after the Ham Fair was over and Dennis had more time, it would be worked on and that LCDRA's group will make the necessary changes so we can make good use of our new DVR in the future. Erv introduced Currin/W8SFZ to the Board, and then gave him time to address the meeting. Currin, who was one of those responsible for creating the Ziegenbein Award in honor of Ralph Ziegenbein after he passed away, has been working on revising the rules for the Award. He said that over the years the rules have been misplaced and the Committee members have gone by what they remembered, so something needed to be put in writing for the new Ziegenbein Committee to follow. Currin said he had worked off a copy that the Secretary Julie/KB8ZXR had in her files from when she had re-typed the rules at the request of Dick Pennington/W8SFA a couple of years earlier. Here are the revised Ziegenbein Award Rules that were approved by the Board on October 6, 2000 and as they were read into the minutes: (1.) THE RECIPIENT MUST BE A CURRENT MEMBER OF CMARC. (2.) NOMINATIONS TO BE MADE IN WRITING, IN YOUR OWN WORDS, NO CHAIN LETTERS TO BE ACCEPTED, STAT-ING NOMINEE'S CONTRIBU-TIONS TO CMARC AND AMA-

TEUR RADIO. (3.) ALL NOMINA-TIONS TO BE KEPT SECRET UN-TIL AWARD IS PRESENTED. (4.) ALL NOMINATIONS ARE TO BE MAILED. (5.) THE SAME PERSON CAN RECEIVE THE AWARD MORE THAN ONCE. (6.) THE COMMIT-TEE SHALL CONSIST OF THE LAST THREE RECIPIENTS, THE SENIOR MEMBER SHALL BE THE CHAIRMAN. (7.) ALL NOMINA-TIONS ARE TO BE CLOSELY CHECKED AND DISCUSSED BY THE COMMITTEE. (8.) IF THE COMMITTEE FEELS THE NOMI-NEES ARE NOT DESERVING, THE AWARD DOES NOT HAVE TO BE GIVEN. (9.) NOMINATIONS ARE TO BE SUBMITTED BEFORE MARCH 15 SO THE COMMITTEE CAN MAKE THE SELECTION AND HAVE THE PLAQUE ENGRAVED. (10.) THE RECIPIENT WILL BE ANNOUNCED AT THE ANNUAL LADIES NIGHT.

The Treasurer said that we received a letter from the Red Cross thanking us for our donation of \$300 and telling us that it will be designated for local disaster relief services, per our request.

Pam then told Erv that she would like to address the membership later in the regular meeting, to ask if there is anybody who is going to work with the Boy Scouts for JOTA ("Jamboree on the Air"), which takes place on the third weekend in October.

Erv said that the Ham Fair Chairman (Bill/ KB8TTS) had sent out a very nicely worded "Thank You" to all those who helped with the Ham Fair, and Erv said he would like to echo those words of "Thanks" also, and take this time to thank the Board members for all their hard work to make Ham Fair 2000 a huge success. Having discussed all of the business at hand, a motion was made by Julie/KB8ZXR to adjourn. The motion was seconded by Steve/W8CRH and approved. The Board meeting adjourned at 7:30 p.m.

Ziegenbein Nomination Guidelines Replaced

After some time without a firm set of nominating guidelines available

for review, the man who brought CMARC's highest honor to the fore, Currin Skutt (W8FSZ), has submitted a revised version of them to the Club. These 'Rules and Regs' were approved by CMARC Board members at the October meeting and, since Currin was instrumental in initiating this Award, it seemed only fitting that he revise them.

They are as follows:

- 1. The Recipient must be a current CMARC member.
- 2. Nominations to be made in writing, on your own words, no chain letters to be accepted, stating nominees contributions to CMARC and Amateur Radio.
- 3. All nominations to be kept secret until Award is presented.
- 4. All nominations are to be mailed.
- 5. The same person can receive the Award more than once.
- 6. The Committee shall consist of the last three recipients, the senior member shall be the chairman.
- 7. All nominations are to be closely checked and discussed by the committee.
- 8. If the committee feels the nominees are not deserving, the Award does NOT have to be given.
- 9. Nominations are to be submitted BEFORE March 15 so the committee can make the selection and have the plaque engraved.
- 10. The recipient will be announced at the annual Ladies' Night.
