GOTA Info.....

John Hosford KC8QZB will once again be control operator of the GOTA station for Field Day 2007. Here are a few FAQ's on the topic.

What is the GOTA station? It is an opportunity for Novice and Technician licensees, other generally inactive licensees, and non-licensed persons to experience first hand the fun of amateur radio by allowing them to GET ON THE AIR (GOTA). The intent and spirit of this station is to provide an opportunity for persons to gain valuable on-the-air experience.

What is considered a generally inactive licensee? The GOTA station is not for everyone. The generally inactive licensee provisions pertain to someone who holds a General or higher class license but has been inactive. This is not a station that a club "ringer" operates in order to rack up points. The list of operators of these station must be submitted with the Field Day entry.

A couple of guidelines to keep in mind when allowing persons to operate the GOTA station

- 1) Any licensee who has never made HF contacts would be considered inactive.
- 2) Someone who has made no QSO's in the last two years would be considered inactive.
- 3) A person who operated the GOTA station as a generally inactive licensee last year would not be eligible to operate the GOTA station in the following Field Day.

What modes and frequencies may the GOTA station use? The modes and frequencies are determined by the license class of the control operator. There must be a control operator permitted to use the frequencies and modes desired in direct control of the GOTA station any time it is transmitting. The GOTA station may operate on any amateur HF band on which Field Day operation is permitted.

What call sign does the GOTA station use? What exchange does it give?
The GOTA station uses a call sign different from the call being used by the group's main Field Day operation. The GOTA station also uses a single call sign for the duration of Field Day.
GOTA stations use the same exchange as its "parent" station.

May a non-licensed person operate the GOTA station? A non-licensed person may participate in the GOTA station by speaking into the microphone, sending CW, or making digital contacts but may do so only under the direct supervision of a properly licensed control operator.
