WHAT'S MY SIGN?

I was born September 30, 1963. I grew up in the country, about seven miles from the nearest towns. I graduated from Pewamo-Westphalia High School and went on to spend a year at LCC for electronics before taking the summer off. I've been working ever since. I am the oldest of three boys and my parents called us the Three Musketeers quite a bit when we were younger.

I have been interested in Amateur Radio most of my life and I am the only sibling that is licensed in my immediate family. Dad is a General Class Ham and I think he was licensed around 1962. Dad used to be Net Control for the Michigan Night Owl Net on Sunday Nights – I believe on 6m AM. Together, we've helped out with a lot of antennas over the years.

One day, I finally decided that "If I don't get my license now, I don't know when I'll ever get around to taking the test!" I fell asleep on the couch studying the manuals and practicing Morse Code many times in my effort to prepare for the exams. Then finally, in March 2001, I passed my first test. I kept studying and was finally able to pass the Extra Class exam. My only regret in Amateur Radio is that I didn't get my license years ago! I had no idea how much Ham Radio would mean to me until I was licensed for a while.

I monitor the 2m band most of the time, and sometimes listen to SSB on HF. I have also done some SSTV and PSK-31. Every once in a while I talk to someone on HF using CW. Even if the Code were not required when I got licensed, I would still want to learn it! Dad had many CW QSO's over the years. Back then, Mom and Dad would copy together to get all of what was sent.

I have a few radios for both 2m and HF: a Yaesu FT-101, Icom IC-207, Icom IC-706MIIG, Heathkit HW-101, Heathkit MT-1 and MR-1, Heathkit HX-20 and HR-20, Heathkit DX-40, Heathkit DX-60, Hammerlund HQ-145 and HQ-100a, and wire antennas for HF and homebrew for 2m.

I enjoy Field Day, Walk-a-thons, and listen to SKYWARN, but usually I am at work so I can't check into the WX Nets. I like to go camping, attending old tractor shows and visiting steam locomotives (both operational and in museums). I am a member of CMARC and LCDRA and enjoy very much going to RAD's Coffee Break and the 539 Breakfast.

As for my personal life, I do Heating/Air Conditioning for a living. My Sweetie (who was licensed before I was) has been my wife now for two years this August. Two "Amateur Radio couples" got us together by playing cards. A couple of years after that, my "now" brother and sister-in-law were in town on there way back home and stayed a few nights. The day after they arrived, we were married!

His often sharp sense of humor made him a quick pal to those in Lansing and we will miss him greatly.

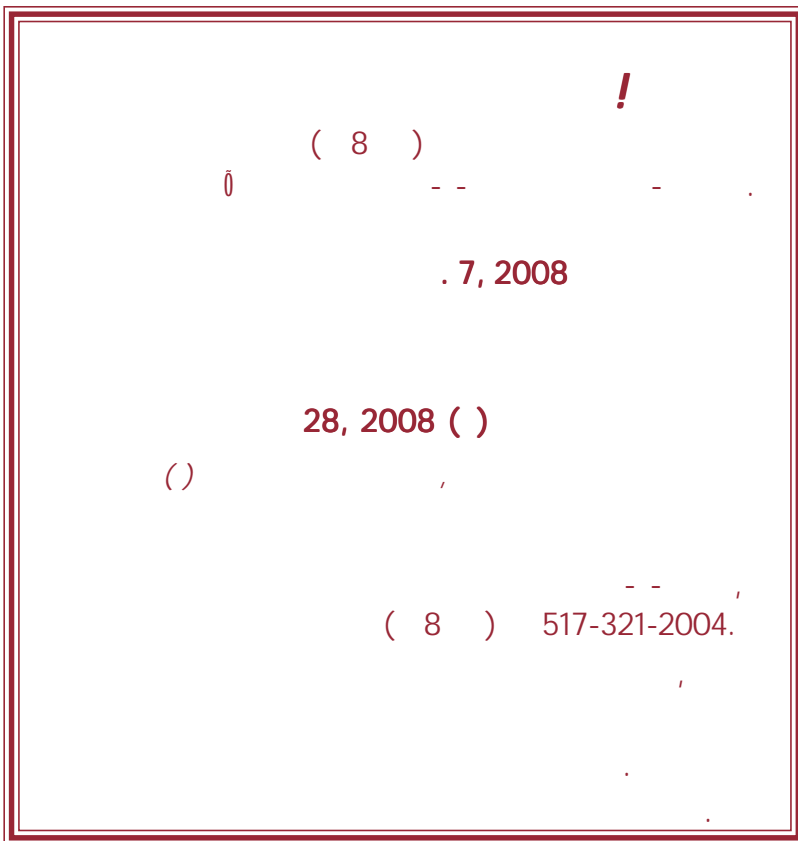


We are pleased to announce the arrival of Chase Douglas Southwell.

CMARC BOARD MEETING • July 11, 2008

President Erv W8ERV called the meeting to order with the following Board members in attendance: DeAnna KD8BDI, Gregg WB8LZG and Corey KD8BOQ. Excused were: Bob K8RDN, Ron WD8BCS and Julie KB8ZXR, who was not able to attend as she had her knee replaced the day before and was still in the hospital. Jeanie Serviss KD8IKO was taking the meeting minutes in her place. There will be no program tonight at the regular meeting – Don Devendorf W8EGI was not able to put his program together, so we'll discuss Field Day (what went wrong and what worked).

Ron Harger WD8BCS has agreed to act as co-chair along with John Hosford KC8QZB for next year's Field Day. They will be working to develop teams for 4 areas with about 7-10 people in each: (1) Set-up (2) Tear-down (3) Meal prep and (4) Clean-up. There is a need for more workers so it's not just a handful doing it all. That seems to be the biggest problem – getting people to commit.

Erv commended everyone for all the food that was prepared and brought in for the meals. He also said that L & L had donated 200 pounds of ice for Field Day, which provided us with more than enough to keep everything cold. He said we should send a "Thank You" note to them. He also said a suggestion had been made that we have the CMARC Club picnic at FD next year, which may act to bring more people out to experience FD. We could also try to have the balloon launch then to help draw attention.

Scott W8ATT had offered his 20' x 20' canopy for FD this year, but we didn't use it. However, it would have come in handy as a place to sit out of the sun, and so we'll keep it in mind for next year.

A question arose in regards to what kind of advertisement we had for FD. Erv said that Bill Cote WD8NYW did a great job, but the TV stations just don't take us seriously and the Lansing State Journal is even worse. After a lengthy discussion and many suggestions, it was decided that we really needed to get the attention of Sheri Jones and Rob Dale N8GSK of WLNS-TV 6 to help us promote FD.

We need to start looking for an alternative location for our FD site as acquiring our present spot is becoming more difficult each year. We'll perhaps look at a few other locations including Burchfield Park, Valhalla Park or the Holt Jr. High School grounds.

Corey announced the Youth car wash would be cancelled for tomorrow because of weather. Another date would be scheduled soon.

DeAnna made a motion to adjourn, seconded by Corey. The Board meeting adjourned at 7:29 p.m.

CMARC MEETING MINUTES • July 11, 2008

President Erv W8ERV called the meeting to order at 7:37 p.m. There was a moment of silence to recognize our Silent Keys.

ATTENDANCE: There were 26 members and 6 visitors in attendance. Our guests were Ruth Hinkle, Mary Lou Tillitson, Lowell Nash K8LPD, Steve N8SR, Tristan Bates and Andrew Temme KE7ESD (a student at MSU).

NEW LICENSES, UPGRADES and VANITY CALLS: There were no new Licenses or Upgrades.

CARDS AND FLOWERS REPORT: There was no report, as Marie KC8NOI was absent. Erv, however, told the membership that Art McMillan WB8KWQ was still in the hospital with pneumonia. Jeanie KD8IKO reported that Julie McLain KB8ZXR was doing well after surgery to replace her knee but was still in the hospital recovering.

INTERESTING DX CONTACTS: Scott W8ATT contacted NU5DE (Naturist Amateur Radio Club of Austin, Texas – a nudist colony!) on 10m, and Gregg worked CY0X on Sable Island on 6m with only 2 watts.

ANNOUNCEMENTS: Dale Williams WA8EFK (the ARRL Great Lakes Division Section Manager for Michigan) will be our guest speaker at the September meeting and John Imeson N8JI (Director of Public Safety at LCC) will be our speaker for the October meeting.

OLD BUSINESS: It was reported that the Scope was still in the process of being printed. A motion was made by Bernie N8PVZ to accept the Secretary's Report as printed in the SCOPE, seconded by Don DeFeyter KC8CY and approved. A motion to accept the Treasurer's report was made by DeAnna KD8BDI, seconded by Gretchen KC8ODL and approved.

NEW BUSINESS: Voice beat out CW at FD this year.

BREAK: As usual, we had some delicious treats due to those who had so graciously volunteered to bring things for our refreshments. A big "THANK YOU" to all those who are always so willing help, not only by making the goodies, but also by working in the kitchen. Your service is greatly appreciated!!

50/50 DRAWING: Elizabeth Stein won the drawing.

UNDER 22 DIRECTOR'S REPORT: The July 12th Youth Car Wash has been cancelled due to weather. We are still planning for the one on Saturday, August 9th and will perhaps schedule another one sometime in August. There was not much to report on until the next meeting, but Corey would like to see every one there.

MAIN PROGRAM AND/OR SPEAKER: Having just completed Field Day, we discussed how things went and what we could do to make things better next year. Erv W8ERV thanked all those who worked so hard to make FD 2008 such a great success. There was a round of applause for John Hosford KC8QZB and for all the hard work he did as this year's FD Chairman. Ron Harger WD8BCS has agreed to act as co-chair along with John Hosford KC8QZB for next year's Field Day. They will be working to develop teams for 4 areas with about 7-10 people in each: (1) Set-up (2) Tear-down (3) Meal prep and (4) Clean-up. There is a need for more workers so it's not just a handful doing it all. A very small hand full was there for clean up Saturday and tear down Sunday. That seems to be the biggest problem – getting people to commit.

Don Cote KD8BD had commented that this was the best Field Day he had seen in years! We made good contacts this time, with the best score in 3 years. The best score on QRP was 344 contacts – up 100 from last year. The Phone station beat its own score from last year and the CW station's score as well. The down side of this station was that they needed more than 1 antenna. We should have more than 1 antenna for each station for replacement purposes, if necessary. Bob Berger K8RDN suspended his antennas in the air with a kite and you could see it for a long distance away. The Amateur TV demo was good. We need to get more youth participation by way of such demos. It was suggested that we have a small series of demos all day long to draw people in and we need to advertise them.

It was mentioned that we should encourage people to visit all of the stations at FD while they are there. All agreed that the food was great this year, as usual. Roger AB8RX said the cords to the Dutch Ovens and Coffee Pots got accidentally unplugged somehow. He said we need to be careful not to do that, and also that we could use a better kitchen. Someone suggested that perhaps we could have the Club's Annual Picnic at FD, and if it rains on Saturday we could have it on Sunday. What a great opportunity to bring out more people! We will take Scott W8ATT up on his offer to lend us his 20' X 20' canopy next year for extra seating capacity.

Erv will recognize many volunteers at the September meeting who worked to make FD a success this year - among them, Linda K8LCC and Wayne W8QG Conklin, along with Kurt KC8QYV. He commended Corey KD8BOQ, who did whatever was needed to be done and was there for hours. It was suggested that we need a small wagon to put a generator on, and also that we need more lights so people can know that someone is still there at the site after dark. Carl K8YHH couldn't tell at night that Erv W8ERV and Bob K8RDN were even there. We also need better signs for improved daytime visibility.

We may not be at Gardner next year because we need a better location. After all, we are a community service organization and we shouldn't have to pay. Besides, we always leave the place cleaner than when we got there. Erv commended Bill KD8HHN for walking the fence line and picking up trash – some of which wasn't even ours! Also, we need a location where the public is. We need to let the public know who we are, how we help the community and what we stand for, because they are clueless. Somehow, we need to get the public's attention. Erv explained Bill Cote WD8NYW's efforts at advertising the annual event. It was suggested that we need Sheri Jones from the WLNS TV-6 Newsroom and Meteorologist Rob Dale N8GSK reporting live from FD. Rob said he would have loved to come out, but that the News Director's priorities do not lean in our direction. Bill KD8HHN told of how the Owosso Argus Press covered FD there with pre-FD articles to draw attention to the event. Perhaps we could contact the local newspapers or even do something through ARRL to alert the public for next year. After all, the Governor proclaims the week of FD as Amateur Radio Week.

CLOSING: A motion to adjourn was made by Bernie N8PVZ, seconded by Scott W8ATT, and approved.
