## League Opposes LA County Experimental Video Proposal

The ARRL has asked the FCC to deny an experimental license application by Los Angeles County, California, to develop a public safety video system on the 2.4 GHz band. The LA County proposal, filed August 9, seeks FCC authorization to develop an experimental system using four 10-MHz channels to transmit video images from helicopter-borne cameras to five remote receiving sites with active tracking antennas. The signals then would be retransmitted via terrestrial links to the public safety agencies involved.

In its objection, filed September 23 with the FCC, the League called the LA County proposal a "foot in the door" toward gaining a permanent berth in the 2.4 GHz band. "It is obvious from the experimental proposal that the County wishes to construct the entire system and then simply stay there," the League said. The ARRL said the FCC should authorize nothing more than a single 10-MHz video channel for a single transmitter aboard a single helicopter, to allow interference studies to be conducted.

LA County already is licensed for video operations on a single 2.4 GHz channel but says it encounters operational conflicts with broadcasters. The proposal targets the 2402-2448 MHz band, characterizing it as "underutilized" and asserting that current occupants—including Amateur Radio and industrial, scientific and medical instrumentation—would not suffer harmful interference. Amateurs have a primary domestic allocation at 2402-2417 MHz.

The League's objection said LA County's 2.4 GHz monitoring study was 'significantly flawed" and 'woofully insufficient," and that LA County would be unable to avoid causing 'constant, harmful interference" to incumbent users. Citing ATV repeaters and video links as well as proposed amateur satellite operation, the

League said, the 2.4 GHz band enjoys significant use by the LA area Amateur Radio community. The League said these systems, and those of other amateur users, would be "seriously degraded or displaced" by deployment of the proposed experimental system.

The decision to grant the proposed experimental license is up to the FCC Office of Engineering and Technology's Experimental Licensing Division. In making its decision, however, the OET is expected to consult with the Wireless Telecommunications Bureau, which oversees Amateur Radio and the other affected services on 2.4 GHz.

In a separate, but related, filing on September 1, Los Angeles County and the cities of Los Angeles, Long Beach and Burbank requested a declaratory ruling from the FCC to "clarify its rules to facilitate public safety operations on the 2450-2483 MHz band" and to explore other spectrum allocations "to accommodate the growing demand for public safety airborne operation." #### FCC SETS SIGHTS ON BEEFED-UP 10-METER ENFORCEMENT

The FCC's Legal Adviser for Enforcement Riley Hollingsworth says hams can expect more rigorous enforcement on 10 meter issues next year. Over the Labor Day weekend, Hollingsworth told visitors to the Shelby Hamfest in North Carolina that the next area of enforcement would be the encroachment of unlicensed individuals into the 10-meter band and a crackdown on illegal RF amplifiers. His announcement drew loud applause from the Shelby crowd. Hollingsworth elaborated on the comments this week in an interview concerning this and other enforcement issues.

"We're coming on to ten months of rejuvenated amateur enforcement now, and two issues are clear—two areas we need to really crank up on next year," Hollingsworth said. "One is the incursion

## ULS VANITY PROCESSING INCHES FORWARD

The FCC's new Universal Licensing System has moved a bit closer to resuming full-scale amateur vanity call sign processing.

Several lucky applicants who had submitted call sign requests in the pre-ULS era benefited in recent days from some "live" testing of the ULS vanity processing system. A few not-so-lucky applicants learned recently, however, that the FCC had to rescind some of those vanity grants it cranked out—and should not have—during those "test runs."

Until a couple weeks ago, no vanity call signs had been granted since August 4. The ULS has been accepting vanity applications since it inaugurated the ULS for the Amateur Service August 16, however. Some 30 vanity call sign applications dating from July were processed September 16. The FCC ran a batch of another 50 or so vanity applications September 21. "We're taking it slow," a ULS spokesperson said.

But while reviewing the vanity applications processed, FCC personnel found some that should not have been granted in the first place, because the applicants made various fatal errors in the application process. The FCC says those call signs will be cancelled and the applications dismissed. "And there will be plenty more, I'm sure," the spokesperson said, anticipating additional dismissals down the road. The FCC has the option of rescinding any grant within 30 days.

Barring any unforeseen major problems, the FCC anticipates additional "live test" runs before resuming full-scale vanity processing, possibly by month's end. Once that happens, vanity call sign processing will occur every day for eligible applications based on date of receipt. Gone under ULS are weekly processing runs and the dreaded work-in-process—or WIPs—stack of applications that were kicked out of the former automated system and designated for manual processing. Under the ULS, applications that would have gotten an additional manual review in the past now will be automatically dismissed and returned to the applicant for correction and refiling.

Vanity applications not accompanied by payments within the 10-day deadline will be dismissed automatically. The ULS now permits applicants to make credit card payments on-line. The fee for a vanity call sign application increased to \$14 on September 14.

In the wake of comments and criticisms about the difficulty of having to configure a dial-up connection with a particular browser (Netscape version 4.5 or higher, and version 4.61 preferred) to file an application, the ULS Task Force says it's planning to convert to electronic filing via the Internet. But a spokesperson says that is not likely to happen for another six to nine months. In the meantime, some have opted to file a paper Form 605 instead. ### FCC DISMISSES FOUR APPLICA-TIONS AS EXAM AU-DIT CONTINUES

The FCC has dismissed four Amateur Radio applications resulting from an examination session in Yonkers, New York, last spring, but its investigation continues. FCC Legal Adviser for Enforcement Riley Hollingsworth wrote the four applicants two months ago seeking answers to specific questions about the May 2, 1999, session conducted by Metro 70 cm Network Amateur Radio Club Volunteer Examiners under the ARRL-VEC. All four were warned that failure to provide the requested information would lead to dismissal of their applications. On September 9, Hollingsworth wrote the same four applicants to dismiss their pending applications.

Dismissed were an Amateur Extra upgrade application from Keith Murphy, KB2YOI, of Spring Valley, New York; a Tech Plus upgrade application from Keith Jones, KC2EDT, of Brooklyn, New York; an Advanced upgrade application from Winston A. Tulloch, KC2ALN, of Paterson, New Jersey; and an application for a Technician license from Claudies Anderson of Detroit, Michigan.

The FCC says Murphy, Jones, and Tulloch failed to respond to the initial inquiry, while Anderson told the FCC that the test papers the FCC questioned him about were not the ones he'd turned in at the exam session.

All four applicants were advised September 9 that "the issues surrounding the examination session" will have to be resolved before the FCC entertains another Amateur Radio application from any of them. Hollingsworth told the ARRL that the next step in the investigation would be to contact the Volunteer Examiners at the session.

In its initial inquiries to Murphy, Tulloch, and Anderson, the FCC questioned the appearance of blue markings next to most answers and asked which marks the applicants had placed on the answer sheets and if any marks were already on the sheet when it was handed out. The FCC similarly queried Jones about his Morse code answer sheet, asking if it was the only one he'd filled out on May 2 and if any of the answers were modified after he'd turned in the sheet; the others who took code tests were asked if they hadwritten down any of their copy, and, if so, what they did with those notes.

Anderson also was asked if he was actually present at the test session and if he'd had access to an answer template before or during the test session. All four applicants also were asked to name the Volunteer Examiners who handed out their paperwork and to whom they gave their completed answer sheets, as well as any discussions they might have had with the examiners. ### HARVARD'S W1AF: 90 YEARS OLD AND STILL GOING STRONG

The Harvard Wireless Club celebrates its claimed status as the oldest Amateur Radio club in the US with a special event operation on the weekend of October 2-3. During the club's 90th anniversary observance, members will attempt to work as many stations as possible around the world.

The Harvard Wireless Club—an ARRL-affiliated club—dates its origin to early 1909, when it was founded by Prof George W. Pierce. First known as the Radio Society of the Institute for Geographic Exploration at Harvard, the club assumed its current name the following year. The W1AF call sign dates back to the early 1920s. Frank Wright, N3OQB, is the current club president.

This year's 90th anniversary special event October 2 and 3will include operation from three HF positions and one VHF position. W1AF will be on the air each day from 1200 to 0000 UTC-24 hours in all. HF SSB frequencies include 3890, 7270, 14,270, 21,370 and 28,390 kHz. HF CW will be 35 kHz up from the lower band edges. On VHF, look for W1AF on 50.150, 144.200 and 432.150 MHz SSB. A special 90th anniversary QSL card will be available for stations working W1AF during the special event. QSL to Harvard Wireless Club, W1AF, Harvard University, 6 Linden St, Cambridge, MA 02138. #### HAM FAIR PLANNING MEETING

**AUGUST 29, 1999** 

CMARC's President Erv/W8ERV brought the meeting to order at 2:15 p.m. Others attending were: LCDRA's President Clint/KC8EHR; Don/KB8RAD; Hal/WA8LAY; Don/WB8NUS; Don/W8BQD; Hazel/K8KSX; and Julie/KB8ZXR.

FORUMS: Erv said he had received confirmation for the DX forum planned for our Ham Fair, but still hadn't heard about the ORP forum. Erv also said he had received complaints about last year's small room for the forums, but that there isn't anything we can do about it at our present location. He said that with the lack of interest and help, he wasn't willing to change location for next year. Clint suggested that we put up a tent or awning outdoors for the forums. It was mentioned that we don't know what the weather will be on Oct. 10th, and that it could be expensive if we rented one and had "them" put it up for us. It was suggested that if it was a nice day, maybe we could at least set chairs up outdoors for the forums.

Erv told the group how he had contacted several places about letting us hold a car wash to raise money for our door prizes, and said he never heard back from them. He then asked what we wanted to do about the prizes, since we already committed ourselves by putting on the flyers that we are going to have better ones this year. From there a discussion ensued and it was decided to go ahead and purchase an HT for the major door prize, anyway, with funds we have currently at our disposal. (Erv will contact Barb and Duane at Communications Data Corporation about getting an HT from them at their cost.)

**DRAWING PRIZES:** After some discussion regarding the drawing of the HT, it was decided that: (1.) The major drawing for the HT will be at 10 a.m. (2.) **TALK-IN:** Hal said he would be doing the talk-in from 5 a.m. to 10 a.m. We still need one other person and will contact Ralph Riggs/N8YQJ.

#### CMARC BOARD MEET-ING

#### September 10, 1999

President Erv/W8ERV brought the meeting to order at 7:35 p.m. All Board members were present except for Bill/ KB8TTS (who was excused for a funeral), and Judd/KC8IRG (who was going to be late). Visitors to the Board meeting included: Don/W8EGI (CMARC's Resident Agent), who brought in Nonprofit Corporation forms to be signed by the President; Don/WB8NUS, who brought in the table layout he has been working on for the October 10th Ham Fair; and Dennis/KB8ZQZ & Mike/ K8MAS (both members of CMARC and the MSU Club), who came to discuss the joint CMARC/MSU Amateur Radio training classes and to get a list of people interested in helping with their efforts.

Erv gave Dennis and Mike time to address the Board with their ideas about the classes. Mike, who is a professor in the Engineering Dept. at MSU (where their Radio Club is located), said there would be no problem with using their facilities. He also said he had secretarial help that could do any necessary copying, typing, etc., that might be needed for the classes. We discussed and consolidated our ideas and came up with the following: (1.) We would like to start the classes in mid-January. (2.) They would be held once a week, for about 10 - 12 weeks. (3.) The classes would be about  $1\frac{1}{2}$  hours long. (4.) We would publicize the classes by contacting area Jr. and Sr. High Schools and the Boy and Girl Scouts. (5.) We would also announce it on the CMARC and MSU Web sites, and in the Lansing State Journal, Community News, and on different TV channels' "Community Calendars". Erv also suggested that we could have The Lansing State Journal, TV-47 or TV-10 come out, once the classes got started, and do a news story on Amateur Radio and the classes.

Mike also asked the Board to approve the implementation of a task force to start organizing the plans for the January classes. A motion was then made by Julie/KB8ZXR to approve the forming of a joint task force. It was seconded by Don/KB8RAD and approved. Mike said

Erv said he had recently received the three publications that the ARRL donates for Ham Fair door prizes, and also that he had purchased an Alinco DJ-195 for \$170 to be used for the grand door prize at the October Ham Fair.

The President then read a letter that the Secretary had received from Glenn Sommerfeldt/KG8LE in which he thanked the Board and members for approving his application for Life Membership.

At the conclusion of our business, a motion was made to adjourn by John/N8LLC. It was seconded by Don/KB8RAD and approved. The Board meeting adjourned at 7:57 p.m.

#### LCDRA MEETING

#### **AUGUST 19, 1999**

At approximately, 7:45 p.m., Clint-KC8EHR called the meeting to order at the pavilion behind the Meridian Township Governmental Complex on Marsh Road as the township forgot to get us the key for our regular site at the Meridian Township Service Center. The following officers were present: Clint-KC8EHR, Scott-W8SRN, Dan-W8BCI, and Don-W8NUS. Don-N8XME was excused. The following members of the association were present: Bernie-N8PVZ, Dan-W8MMQ, Bob-N8TNT, John-AA8LF, Hal-WA8LAY, Dennis-KB8ZQZ, Jim-KA8DDQ, and Ralph-N8YQJ.

Old Business - First, Scott-W8SRN read the minutes of the association's last meeting in June 1999. Scott reported that a technical glitch prevented Cary-KC8JKA from printing the June minutes in the August Scope. However, Cary said that the June minutes would be printed in the September edition. Scott also read the thankyou letters to John Schafer-N8ZMT and Brent A. Williams-WB8TRL.

Don-WB8NUS gave his treasurer's report. As of August 19th, the Association has a balance \$8,378.68. Since our last meeting, LCDRA spent \$270.46 and received \$412.99 in revenues. Don reported that we have 111 paid members with 39 people dropped from the rolls for non-payment. Last, Don informed us that Old Kent is now our bank due to a merger and will not be paying us as much interest on our accounts.

With respect to the swearing problem on the Association's repeaters, Dan-W8BCI reported that he spoke with the individuals involved, and it appears that the problem has been resolved. Instead sending out a letter, Dan moved that Clint-KC8EHR, who had earlier volunteered, speak with the scofflaw personally to ensure fairness. Don-W8BQD seconded the motion. Motion carried.

New Business: - Tom Shaver, Lansing's Emergency Management Coordinator, announced that the City had an eye-opener on May 7, 1999 when the severe storm, which packed 100 mph winds, roared through the area. As a result, the

City determined that it needed the local amateur radio organizations help in emergency situations. Further, Tom, who is currently studying to take his licensing examinations, told the Association that the Emergency Center for the Unified Command Team, which is composed of the Lansing Police Department, Lansing Fire Department, Lansing Board of Water & Light, and the City's Department of Public Works, will be moved to the basement of the Number 8 Firestation at Grand River and Marshall. A room in the EC will be specifically set aside for amateur radio operators so they can help the City with emergency communications. Tom stated that the City will purchase radios, antennas, and other equipment for our use. To help facilitate our integration, Tom asked for the Association to write an Annex for the City's Emergency Action Plan. Clint-KC8EHR, Hal-WA8LAY, Jim-KA8DDQ, Dennis-KB8ZQZ, and Scott-W8SRN volunteered to spearhead this endeavor.

Don-WB8NUS reported that the planning for the Ham Fair is going good. Right now, we only have 28 tables left to be sold. In fact, KC Accessories recently purchased several tables. Further, Don reminded the group that this is the last ham fair that he will be in charge of as he will not seek another term as treasurer.

Next, Dan-W8BCI reported that the group needs to purchase a back-up controller for our repeaters. Currently, each repeater has a controller, but there is no contingency for a malfunction that cannot be immediately fixed. Dan moved that we purchase another CAT-300 controller. Bob-N8TNT seconded the motion. Motion carried unanimously.

Dan-W8MMQ reported that the time-outtimer on the 146.94 repeater seemed to be set too short. Bob-N8TNT stated that he believed that the controller was timing-out the machine after the person had been transmitting for approximately 1-1/ 2 minutes. Dennis-KB8ZQZ apprised the Association that the timer should be set to 3 minutes, but he would check as to the exact length of the timer and adjust as needed.

In keeping with the repeater questions, John-AA8LF asked whether the 100Hz

tone had been turned on the 145.39. The group was informed that the controller was all set and the tone merely needed to be turned on. Dan-W8BCI moved that we turn on the tone immediately. Bob-N8TNT seconded. Motion carried.

As a reminder, Don-WB8NUS told those assembled that officer nominations and elections were to be held at our next meeting on October 21, 1999. Clint-KC8EHR directed that an announcement to this effect be placed in the September Scope.

Last, but not least, Don-WB8NUS moved that we adjourn for the evening. Bernie-N8PVZ seconded. As usual, the motion carried with no dissent.

#### **Just In Case - ARPSC**

The Mid-Michigan chapter of the American Red Cross is making contingency plans for Y2K. While not expecting any great problems, plans call for opening as many as four shelters in the greater Lansing area. In the event it is necessary to open any shelters, our ARES-RACES group of trained operators, ARPSC, (Amateur Radio Public Service Corp), would be expected to furnish radio communications for the shelters.

Each shelter would require a maximum of two operators (or one operator and an assistant-trainee) plus two for the chapter house radio room and possibly another two for a link to the city OEC Emergency Operations Center. It is time to start making our communications plans "Just In Case" we are needed.

Remember, one reason we enjoy the privileges we have and the frequencies we occupy is our ability to respond in case of emergencies. Our record is good but we can not rest on our record. We must plan ahead and be ready to respond to Y2K or any other potential emergency.

#### Information From Director Candidate George Race - WB8BGY

What My 300 Word Statement Really Says, In A Lot More Words

("Quoted" paragraphs from are from my 300 word statement) "Amateur Radio faces many challenges as we approach the Millennium. Let's meet them together! Antenna height restrictions, sharing our bands with Commercial interests, the imposition of RF Safety Regulations and wide-ranging changes in our Rules and Regulations are some of the challenges we face in the next three years."

We must work together as we move toward the year 2000 and beyond. One of the best pieces of work, accomplished by the Board, has to be PRB-1. You may not realize it but past Great Lakes Director Nathanson, W8RC, did much of that great piece of work during his service on the board many years ago. Several States have now adopted PRB-1 to serve as their guidelines when dealing with Amateur Radio tower restrictions. One of my goals, working with Division Amateurs, will be to see the States of Kentucky, Michigan, and Ohio adopt PRB-1 as the defacto means of dealing with Amateur Radio tower restrictions. I believe it can be accomplished, by proper petitioning of our three State's Congressmen and Senators. It will take a lot of work on your part as well to make this reality. The fight to keep Commercial interests from taking over Amateur frequencies has to be one of the highest priorities for any Candidate for League office. When reelected as your Director, I will keep you fully informed of any impending legislation that could impact our frequencies. You, as League Members and voters, do have the ability to persuade our Elected Government Officials to vote against these kinds of actions. But, you have to be informed and get involved to make it possible.

As I am sure you are aware, the current Board of Directors put their stamp of approval on suggestions for changing our Rules and Regulations last January. The impending FCC action is being awaited as I write these words. I know that Great

Lakes Division Amateurs are concerned about the possibility of wide sweeping changes in our Part 97 Rules and Regulations. At this point in time, all we can do is wait for the FCC to announce the changes. Do I think it will have an effect on Amateur Radio? You bet I do! It will take all of us working together, to make whatever changes are announced, work smoothly and efficiently as possible. Then there will be the inevitable need to find tune the results of the Rule Making. I am sure that working together, we will be able to make the proposals that will be of benefit to all of Amateur Radio. Your input and opinions will be most important. As your elected Director, I will be looking for ideas and thoughts from all of the Division Amateurs, who I know are going to be affected, by this impending FCC Rule Making.

"The League needs experienced, energetic leaders who represent the mainstream of Amateur Radio and listen to members. Leaders who help members solve their problems and take ideas for improvement to the Board."

I have been a League Volunteer since early in 1979 when I became the Emergency Coordinator for Jackson County Michigan. Since that time I have served in most of the League positions at the State level. I became Section Emergency Coordinator in 1985. Over the next few years, working with Michigan Amateurs, I put together one of the most successful ARES/ NTS/RACES programs in the Nation. During my six years as Michigan Section Manager, Michigan became the recognized leader in the National Simulated Emergency Test. Michigan became the first State in the Nation to integrate ARES, RACES, and the NTS into a comprehensive smooth working Organization. The story of these accomplishments, and how I did it working closely with Michigan Amateurs, can be found in the ARRL Emergency Coordinators Manual, and has set an example that has been followed by other League Organizations throughout the Nation.

As your Candidate for Director, I have the experience of 20 years of leadership in the ARRL. I have always been known as a good listener who takes pride in solving issues brought forth by Amateurs, League Members or not. What is most important is Amateur Radio. As your Director, I will do all that I can to promote your ideas and concepts, both at the Board Committee and Board Level.

And let's not forget, we need to keep Amateur Radio fun! How easy that is to forget, if we are not careful in the way we think about our hobby.

"Working together we can strengthen our commitment to Public Service communications, generate renewed interest in formal traffic handling, and build our Amateur Radio image to a new high."

As Amateur Radio Operators, we control many megahertz of prime spectrum. The only way we are going to continue to justify our control of so much spectrum is through our continued commitment to Public Service Communications. In the times of Disaster, knowledge of formal traffic handling is a must. We must continue to strengthen our support of formal NTS nets by bringing new members into the system. 
