

## FCC'S HATFIELD TELLS HAMS TO "WALK THE WALK"

The FCC's Dale Hatfield, W0IFO, predicts a bright future for Amateur Radio. But the Office of Engineering and Technology chief says that amateurs "will be under a certain amount of pressure" to justify their free use of the radio spectrum. As a result, he said, it will be more important than ever that hams actually fulfill their service, good will and educational roles—not just talk about them.

Hatfield offered his observations as keynote speaker for AMRAD's 25th anniversary dinner June 17 in Virginia. Hatfield told the gathering, "the key issue for the amateur service is maintaining access to an adequate amount of spectrum." While emphasizing that he was not suggesting any immediate threat, Hatfield said hams will have to do a better job of justifying their current allocations.

Hatfield said hams should actually engage in experimentation to advance the state-of-the-art, provide communication and train operators for emergencies, encourage international cooperation and good will, and offer an important technical educational outlet. "Or, to use a bit of slang, it seems to me that it will be even more important for all segments of the amateur community to 'walk the walk' not just 'talk the talk'," he said.

Hatfield encouraged his audience to explore advanced techniques that conserve spectrum, especially digital techniques. As the rest of the telecommunications world transitions to digital techniques, Hatfield said, "the amateur service will look antiquated if it is not making progress in that direction as well."

Hatfield also said software defined radios could facilitate "a new era of amateur experimentation" and, in many ways, represent "a final merger" of radio communications and computers.

## MUSEUM SEEKS DONATIONS FOR GOLDWATER HAM EXHIBIT

The Arizona Historical Society Museum is seeking donations to reconstruct the well-known Amateur Radio station of the late Sen Barry Goldwater, K7UGA. Goldwater's amateur equipment, memorabilia and furnishings were donated last year to the Society's museum in Papago Park in Tempe.

Director Reba Wells Grandrud said the museum will need \$77,000 to set up a "high-quality exhibit" of the massive station console and equipment "as the late Senator used it." The museum's display designers likely will use digital photographic techniques to replicate the interior of the original room as well as the desert views seen from the windows, "to make it feel like you're walking into Barry Goldwater's ham shack, Grandrud said.

It's not likely the Goldwater museum station will be operational, but Grandrud said the museum might "simulate" an operating setup for the sake of visitors. Grandrud said the museum will be putting the exhibit together between now and February.

The K7UGA station equipment and console were removed in May from the Goldwater home in Paradise Valley, Arizona, which has been sold. Before it was dismantled, museum personnel photographed the setup and inventoried and cataloged all of its components.

Goldwater's station and massive antenna system were used to complete thousands of phone patch messages for troops during the Vietnam War. Goldwater died two years ago. The K7UGA antennas since have been sold to private buyers and will not be a part of the museum exhibit in Tempe.

## ANTENNA DE-SIGNER LOUIS VARNEY, G5RV, SK

The Amateur Radio world is mourning the loss of R. Louis Varney, G5RV, who invented the world-famous G5RV antenna. Varney died June 28, at his home in West Sussex. He was 89 and had recently been reported in failing health.

The G5RV multiband wire antenna for HF—typically 102 feet on the flattop section—is among the most popular of all antenna designs. Varney first described the G5RV in the November 1966 issue of the RSGB Bulletin. While models fed with coaxial cable have proliferated, Varney's personal recommendation was to use a balanced feed line and a matching network for bands other than 20 meters. (The G5RV dipole is discussed in Chapter 7 of The ARRL Antenna Book.) Varney had a full-size and a double-size G5RV, both fed with open-wire feeders, at his own station.

Varney was an RSGB member for 74 years, and he served as life president of the Mid-Sussex Amateur Radio Society. His wife Nelida is among his survivors. Services were set for July 4 in Brighton, England.—thanks to Bob D'Imperio, N4XAT, and RSGB for this information

# Big Changes Coming in Local Emergency Management

County EC Outlines Plans for the Future

It's not very often that I write an article to be placed in the SCOPE. In the near future there will be more, written about the local Amateur Radio Public Service Corps (A.R.P.S.C.) This group incorporates three groups, and the training for the groups are together. The groups are A.R.E.S., N.T.S., & R.A.C.E.S.

I was asked to be the county E.C. and I was very excited and eager to accept. I didn't know what my responsibilities were, but from things I had heard at the time, I knew it was something I wanted to get involved in I later appointed Cary Britten as an Assistant E.C. That made one E.C. and three assistant E.C.'s. Later, Bill Anderson, Cary Britten and myself went to an E.C. Orientation. There I learned that more assistants were needed. It was recommended to have at least 5 Assistants. WOW!!!!!!!! I couldn't believe it.

Well, I needed an Assistant E.C. as my liaison for SKYWARN. That was an easy one. I wanted someone whom I KNEW would fulfill the obligations and be a good leader in that area. Someone who knew more about meteorology than any one I could think of. Of course, I asked Jaymes Kenyon KC8DJH. He accepted and we got him rolling. He has been running with this like a mad man. He has developed a preamble for the Standby Nets, as well as the Fully Activated Nets. He's got a method in place

for running it neatly and organized and he constantly develops things as time passes. Jaymes will be the primary Net Control Operator and has been endorsed by both Don Tillitson (WB8NUS) and the National Weather Service. As time moves forward, there will be better SKYWARN trainings. We have an EMWIN system up and running at the Lansing E.C.C. and we gave it a try. During the last storm that moved through, Bill and Jaymes were at the Lansing E.C.C. Bill was the Lowell Liaison and Jaymes ran the net. That eliminated the traffic between the two, leaving more available airtime for emergency traffic. Also, they had up to date warnings and such posted on the EMWIN system. He can also watch the storm as it moves in the area. In time, this same system will inform us of severe weather, via our pagers and also will serve as a relay station. This will allow the net to have the flexibility to be run from nearly anywhere with the same capabilities.

I also asked Lowell Corbin to be an Assistant E.C. He accepted. He is the Liaison for our NTS. This is a rather new area for appointment and for myself as well. We will be checking into state net(s) and handling emergency traffic. Lowell brings with him great experience for this, because he was at one time a District Emergency Coordinator. We will be developing our nets in proper traffic handling methods. Correct phonetics and prowords are necessary. But of course, we don't all know how we should be the most effective in handling any type of traffic. Including myself, I am learning many things that I have been doing wrong. But it is sooooo exciting to learn and to help. We are finding that we are needed more than we had imagined.

I could go on forever, but I don't want

to take up the entire SCOPE. I hope to be able to express what is happening in A.R.P.S.C. to each and every person. We definitely could use more help. I hope to see every one there.... honestly...everyone:)

#### **LCDRA MEETING**

APRIL 20, 2000

At 7:35 p.m., Don/N8XME called the meeting to order with the following officers present at the meeting: Don, Scott/W8SRN and Harold/WA8LAY. Brad/KA8RAD, Clint/KC8EHR, and Gene/N9XAM were excused. The following members also attended the meeting: Cary/KC8JKA, Dan/W8BCI, Tom/KC8NJK, Don/WB8NUS, Don/W8BQD, Hazel/K8KSX, Randall/KC8IHV, Ralph/N8YQJ, Dan/W8BCI, Jim/KA8DDQ, and John/

#### AA8LF.

#### **Old Business**

First, Scott/W8SRN gave the secretaries report. Dan/W8BCI moved and Don/W8BQD seconded the adoption of the report. The motion carried. In Gene/N9XAM's absence, Don/WB8NUS gave the treasurer's report. Dan/W8BCI moved, and Scott/W8SRN seconded the adoption of this report as well. Motion carried.

Next, Dan/W8BCI reported that Abe/W8HVG purchased equipment so we could have a remote receive site for the Link in the Lansing area. The receiver site would use a 70 cm transmitter back to Onondaga and would be located at Ingham Medical Center so we could utilize the antennas already in place. Abe believed that cost for this unit will run less than \$200. In order to help ensure that this installation would go smoothly, Don/W8BQD moved that we donate \$200 to the Independent Repeater Association to help defer the cost. Tom/KC8NJK seconded. Motion carried.

Tom/KC8NJK reported the City's Emergency Management Committee met on April 18, 2000, and they loved the ATV repeater idea. In order to cure the security problem, the Committee decided to use 70 cm. from the field to the repeater site and 1.2 GHz. to the remote sites at the EC and the Ingham County Sheriff's Department. Tom said that we needed to coordinate the frequency pairs for these services and that Rohn Tower needed to certify that the existing tower would hold

the feedline/antennas needed for this repeater. Last, the City's Radio Lab wanted to run a quick intermod study to ensure that the new equipment would cause any interference to the City's equipment. Last, Don/N8XME again introduced the plan to move the meetings back on a quarterly schedule. Scott/W8SRN agreed that we could get back on the old schedule by having the next meeting in July 2000. Dan/W8BCI moved that the Association move its the meeting schedule back to quaterly and John/ AA8LF seconded. Motion carried unanimously.

#### **New Business**

Dan/W8BCI stated that due to problems with interference, the organization may want to PL the input of the 146.70. As usual, many amateurs in the area do not have tones on their radios. As well, this repeater is the home of the local autopatch. Due to these concerns, the matter was tabled.

Don/WB8NUS asked for volunteers at various upcoming public service events. Don asked that anyone interested in the following events contact him: (1) MS Walk on May 7<sup>th</sup>; (2) MS Bike-A-Thon on July 15<sup>th</sup> and 16<sup>th</sup>; (3) the Magic Ride on June 10<sup>th</sup>; and (4) Women on Wheels on July 22<sup>nd</sup>.

Don/N8XME reported that Forrest/ N8PWD's wife Joyce died after a sudden and short illness. The members of the Association extend their condolences to Forrest and his family. Per custom, CMARC will arrange for the flowers. Dan/W8BCI was happy to inform the Association that WILX-TV, Channel 10, will again use the local SkyWarn personnel this year to supplement their local storm coverage. In fact, the station will put up a 70 cm. antenna so those present at the station will be able to contact the SkyWarn people in Eaton County for information pertaining to incoming storms. Again, the primary Weather Bureau frequency will be 145.27 MHz. with a PL of 94.8 Hz. and a secondary frequency assigned to 147.26 MHz. with a PL of 94.8 MHz, as well.

John/AA8LF inquired into the apparent interference between the 146.70 and the 146.94. John informed the group that he and Cary/KC8JKA determined that one could cause the interference with as little as 2 watts. Dan/W8BCI hypothesized that the problem actually may be a telephone wire on the 146.70's controller that was left outside the cabinet. Dan will coil this wire up and place inside the cabinet as soon as he can. Hopefully, this simple fix will cure this recent problem.

John/AA8LF also wondered if the Association was going to put a proper 70 cm. controller on the 145.39. Right now, this repeater uses a telephone control instead. This matter was tabled until Dan/W8BCI can get to the problem.

As no new business was forthcoming, Scott/W8SRN moved that we adjourn the meeting. Don/WB8NUS seconded the motion. With no surprise, the motion carried.

## Freedom Wasn't Free!

Here is a little flag waving for you ......Have you ever wondered what happened to the 56 men who signed the Declaration of Independence?

Five signers were captured by the British as traitors, and tortured before they died. Twelve had their homes ransacked and burned. Two lost of their sons serving in the Revolutionary Army; another had two sons captured. Nine of the 56 fought and died from wounds or hardships of the Revolutionary War.

They signed and they pledged their lives, their fortunes, and their sacred honor. What kind of men were they?

Twenty-four were lawyers and jurists. Eleven were merchants, nine were farmers and large plantation owners; men of means, well educated. But they signed the Declaration of Independence knowing full well that the penalty would be death if they were captured.

Carter Braxton of Virginia, a wealthy planter and trader, saw his ships swept from the seas by the British Navy. He sold his home and properties to pay his debts, and died in rags.

Thomas McKeam was so hounded by the British that he was forced to move his family almost constantly. He served in the Congress without pay, and his family was kept in hiding. His possessions were taken from him, and poverty was his reward. Vandals or soldiers looted the properties of D i l l e r y , H a l l , Clymer, Walton, Gwinnett, Heyward, Ruttledge, and Middleton.

At the battle of Yorktown, Thomas Nelson Jr, noted that the British GeneralCornwallis had taken over the Nelson home for his headquarters. He quietly urged General George Washington to open fire. The home was destroyed, and Nelson died bankrupt. Francis Lewis had his home and properties destroyed. The enemy jailed his wife, and she died within a few months.

John Hart was driven from his wife's bedside as she was dying. Their 13 children fled for their lives. His fields and his gristmill were laid to waste For more than a year he lived in forests and caves, returning home to find his wife dead and his children vanished. A few weeks later he died from exhaustion and a broken heart. Norris and Livingston suffered similar fates.

Such were the stories and sacrifices of the American Revolution.

These were not wild-eyed, rabble-rousing ruffians. They were soft-spoken men of means and education. They had security, but they valued liberty more. Standingtall, straight, and unwavering, they pledged: "For the support of this declaration, with firm reliance on the protection of the divine providence, we mutually pledge to each other, our lives, our fortunes, and our sacredhonor."

They gave you and me a free and independent America. The history books never told you a lot about what happened in the Revolutionary War. We didn't fight just the British

We were British subjects at that time and we fought our own government! Some of us take these liberties so much for granted, but we shouldn't. So, takea few minutes while enjoying your 4th of July holiday and silently thank these patriots. It's not much to ask for the price they paid.

Remember: Freedom is Never Free!

I hope you will show your support by please sending this to as many people as you can. It's time we get the word out that patriotism is NOT a sin, and the Fourth of July has more meaning than beer, picnics, and base-ball games.
