The "539"

The Lansing Civil Defense Repeater Association was formed in the 1970's by Jim Holcomb, WA8KZY; Jim was then the director of emergency communications for the City of Lansing. Its main function is the operation and maintenance of the four repeaters, 145.39 Mhz, 146.94 Mhz, 146.70 Mhz and the 224.98 Mhz system. The 145.47 IRA link repeater is also maintained by LCDRA, however, the equipment is owned by the IRA.

Jim Harvey, KA8DDQ, has been involved in the technical side of obtaining and operating the repeaters from early on. Jim says the .39 was put on

in April of 1979. Somewhere along the line a Maggorie repeater was obtained because it has been used for backup when the later model unit, the Motorola MICOR, failed because of mice. Jim was the person that obtained the MICOR early, when they were not available as surplus, as they are today.

As president of LCDRA my part in this has been to backup Jim's efforts with as much Motorola equipment as possible. Presently we have two MICOR repeaters at the Dobie repeater site, repeaters A and B. Jim also has a complete third unit at his place for back up if either of these units were to fail. Currently we have a separate simplex UHF control station at the Dobie site so that we can control repeaters A and B by remote, this is, away from the site itself. The control station allows us to turn the repeaters on and off, go to either A or B, or turn off the AC power to the repeaters to allow us to exercise the battery backup that each unit has. All three repeaters A and B and the control station have their individual NICAD type 12 volt batteries.

At Ingham Medical, where the .94, .70 and the 224.98 repeaters operate, we have backup for all of these machines as well. The control station for Ingham is currently being completed at my place, as is the 224.98 machine. The .94 and the 224.98 machines are both Motorola MICOR units. The .70 machine is a Motorola MOCOM 70 unit. We also have a Maggorie repeater if either of the MOCOM 70 units fail. The MICOR 224.98 machine is completed waiting for programming the CAT 200 controller.

All repeaters in the LCDRA group have a PL of 100 Hz, except the 224.98 machine which is standard squelch. The newer MICOR machine, about to be taken to Ingham, will have PL on transmit as well as the receiver, however, the receiver decoder will be left off at this stage. It has been installed in the unit,
