I realize that this is not an excuse for the way I handled this, but I'm being honest. In conferring with the other Ziegenbein committee members after the fact. It was agreed upon that the award was indeed given to the right person. I ask forgiveness from the membership, the Ziegenbein committee, and especially DeAnna Barnhill, for errors I have made in this regard. I do not wish to see this award tainted in any way because of mistakes I have made. I still believe with all my heart that this award is the greatest honor any ham can ever receive. Please accept my apology.

Field Day 2007 CW Station

Well, another Field Day has come and gone, and a good one it was, too. We had a blast. Friday evening found several ops out in the woods checking out the best locations for their antennas, and several of us put up 450 ft of wire up about 75ft in the air in a "Bi - Square" configuration for 80 meters. Saturday morning we hoisted up 20 and 40 meter dipoles, and we were ready for action. This year the club ran "2A" again, however at the CW station we ran 2A, "officially", but actually ran a K2 at about 5 watts, battery power, and completely charged by solar power. Some folks may think running QRP in a contest with the Big Guns is just a bit crazy, but we were very successful at it last year and it's a great challenge. Besides, us QRP'ers are well known to be crazy. The big long wire was OK on 80m, but I'd hoped for a bit better performance. In retrospect, I think a dipole would have done just as well, but that's part of what Field Day is all about, testing and trying a new antenna that you may not have the real estate for back at the home QTH. We did 247 QSO's, plus solar power bonus. Down a bit from last years effort, but very respectable when u consider that we sat 2 new contesters in the "HOT SEAT" for several hours and they had the time of their lives. Those of u who didn't get out to see us missed the best FD chow in years. A&W hot dogs, root beer, tater salad, beans for lunch. Pot Luck style dinner. Quiche, fruit, donuts and juice for breakfast and to top it all off we had a "tear down" meal of BBQ spare ribs! It just doesn't get any better then that. I think I gained 10 pounds over the weekend! I'd like to thank all the ops and loggers who came out to help. Good friends, good fun, good food. That's Field Day. Hope to see all of you out there next year.

### **"A BLAST FROM THE PAST!"** by Julie McLain/KB8ZXR

This month, in lieu of the new column, "WHAT'S MY SIGN?", we are instead featuring "A BLAST FROM THE PAST!". Many of you have asked Don McLain/KB8RAD and I if we knew what had become of a past Board Member/Ziegenbein recipient, and with the recent SKYWARN Nets this question has come up even more. Well, we've decided to answer this question for you.

Jaymes Kenyon/KC8DJH is still busier than ever and loving every minute of it. In spite of his tight schedule, he was so kind to answer the following questionnaire for me so those who know him can be updated on his activities, and those who don't may get to know this fantastic guy they keep hearing about!

1. When and where were you born? Are your parents or siblings Ham's? If so, what are their Call signs?

I was born in 1983 in Lansing. I'm from a family of four with a younger brother. My Dad is also a Ham (Dave/KC8ODU).

2. How did you get interested in Amateur Radio?

Growing up, I was fascinated by the weather and aspired to be a Meteorologist. During one severe weather episode, I was listening to a broadcast radio station doing cut-ins to cover the situation. Reports from "Storm Spotters" were mentioned on numerous occasions, and I became aware of their unique role in the warning process. I inquired at the National Weather Service about becoming a Spotter, and attended training at the first opportunity. It was during SKYWARN training that I learned about the essential role of Amateur Radio and resolved to earn my license. I was drawn to Ham Radio by its practical application to Storm Spotting; little did I know that I was embarking upon another wonderful hobby.

3. When were you first licensed and what's your License Class?

I was licensed as a Technician in 1996 at the age of 12. I soon took an interest in CW and upgraded to Tech Plus and then General.



**4. What's your favorite mode of communication? (2 metros., 440, CW, etc.)**

I thoroughly enjoy CW operating, particularly on 40 and 15 m. But I have never lost sight of 2 m FM phone, which drew me to the hobby originally, and where I have made many friends and memories over the years. I also have a 2 m packet setup.

**5. What kind of equipment do you have now, or interesting stories about some you've made (Heath kit, etc.) or had before.**

My current setup is very limited...just a handheld and a 2 m rig in my truck. I am in the process of re-establishing my HF station at my new location. My current HF rig is a Kenwood TS-570D with a Bencher paddle. But my original HF setup consisted of a separate Heath kit transmitter and receiver (with tubes), a straight key, a vertical antenna for 15 m, and a 40 m half-wave dipole antenna. I was able to work the world with a very modest setup...and had a great time doing it.

**6. Do you have a favorite Amateur Radio service or event you enjoy doing best? (SKYWARN, Walk-a-thons, Contesting, Field Day, etc.)**

When I was still in Michigan, I was very active with SKYWARN. I have also worked numerous walk-a-thons and Jamboree on the Air (JOTA) events. Also, I have always loved the excitement and fellowship that comes with Field Day.

**7. What did you do after graduating from High School (college, etc.)? Why did you choose to join the Air Force? Tell us something about what you are doing now, your rank, and where you are stationed?**

I attended Valparaiso University (in Indiana) after graduating from Eaton Rapids High School in 2002, and enrolled in the ROTC program at Notre Dame to train for a commission. I graduated and was commissioned in May 2006 with a B.S. in Meteorology and began active duty service in the U.S. Air Force the following month with the rank of Second Lieutenant. I am currently stationed stateside at Barksdale AFB, Louisiana as a lead Meteorologist with the 26<sup>th</sup> Operational Weather Squadron. We are responsible for preparing forecasts, watches, and warnings for all Air Force and Army installations within a 9-state region, as well as transient aircrew briefings and contingency support. I chose to become an Airman and an officer for the opportunities to lead, to gain experience, and to make a difference. It is a good way of life, and was a great decision. I'm living a dream. I'm currently on temporary assignment to Keesler AFB in Biloxi, Mississippi for Advanced Weather Radar Training, but will be done on July 6 and headed back to Louisiana. I'm coming back home, on leave, to Eaton Rapids July 14-23 and would love to catch up with my old friends.

**8. Do you have any other interests or hobbies you'd like to tell us about?**

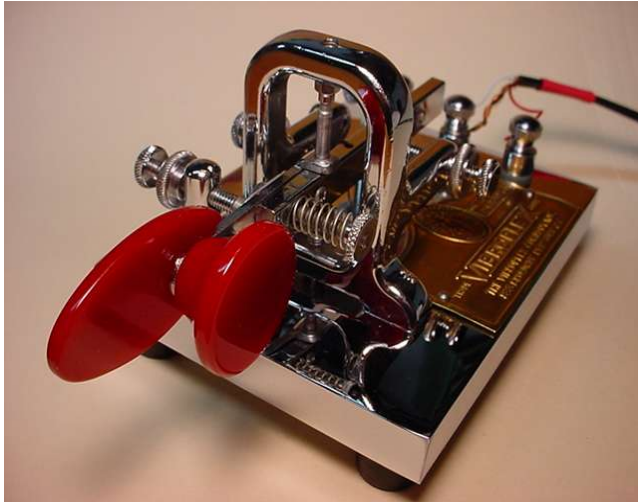
I'm also an avid sailor and spend afternoons sailing whenever I can.

This is the single lever model, and will not send like an "iambic" Dual Lever paddle, but some ops prefer the single lever action and feel.
