The base was slimmed down to make more room on the operating desk. Manufactured during the 40's this bug did not catch on in popularity like the Famous Les Logan 501 bug, so they are a bit rare. A Letter from the President

Greetings to one and all!!

From time to time I run across an issue or issues that I feel need to be addressed, this is one of those times. This time it's the desire on the part of some to move the club. There are reasons both for and against, I'll start with the "for" side of the issue.

- 1. As everyone knows, the club station is hard to get to, mostly due to security concerns of the Red Cross. That is not likely to change.
- 2. The Red Cross's desire is to have those with access to the building/club station be registered as Red Cross volunteers. (That's presently applicable to the club board and the club call sign/station trustees, not to the membership as a whole, but may someday become an issue for others...) That would not be much of an issue were it not for their National Leadership's requirement that volunteers undergo a background check, to include a credit check and a standard of living check, all done by an outside agency that takes it's authority from the Fair Credit Reporting Act, not a Law Enforcement agency. I for one find this to be disturbing, and something that I'm not really in favor of, especially since I've gone through many background checks during the years that I've done Security work, not to mention those done so I could volunteer as an ARES/RACES member, etc. Note: All of the other background checks I've been through were done under or through a Law Enforcement agency's authority, which is as it should be in my opinion. (Yes, I'm a Red Cross volunteer, and as such, have underwent most, if not all, of their required checks, but that doesn't mean I liked it. I did it because I'm a service oriented type of person, and wanted to do something to make a difference in someone's life.)
- 3. Equipment issues, such as the distance from the antenna(s) to the radios. This becomes an issue based on the length of the coax run and the potential losses in signal and gain caused by long runs.

Now for the "against" side of things:

- 1. Club station call W8PLP, which was Ralph Ziegenbein's, is assigned to the Mid-Michigan Chapter of the Red Cross. If we leave, we most likely won't take the call with us to our new home/station.
- 2. We don't have the money to relocate, not only for renting a place for the club/station, let alone buying/building a location. Speaking of money, we couldn't afford the cost of utilities, or insurance, on the new club location for very long based on what is in our credit union account(s).
- 3. Club station equipment. Most of what we have is old and/or outdated, particularly in the case of the club's computer. There is also the fact that it was put there to support the Red Cross, and should remain there for that purpose if we leave. As in item #2 we don't have the money to buy new equipment. There is a possibility that we may set up a new station at one of the local churches, but that has never been meant to be a replacement for CMARC, rather it was to be an extension of CMARC. There was an offer of equipment made by a club member, however there is already equipment available for the church station should it ever come to fruition.
- 4. Regarding the church, and moving the station/club there: The current Pastor is largely in favor of having a club/station. However, in the event of a change in Pastor and/or Church leadership that could change. I don't wish to find ourselves become homeless, and doubt that anyone else in the club does either...

There's a committee in place to study the issues above and report back to the membership with its finding(s) and their recommendation(s). I strongly urge the membership to let them do their job, and then we can decide on a course of action that will be in the best interest of the club as a whole based on their input.

(My vote, for what it's worth, is for us to stay put until a viable permanent option becomes available. Something that I don't see at the moment.)
