This month's "Key of the Month" is a homebrew beauty that comes to us from W8FSZ, Currin Scutt. It was crafted in a machine shop in Montegue, Mich. This is one of several keys made. I happened to meet up with the artist at a swap in Lowell where he showed me the "straight key" version he had also made. This one is a dual lever paddle made with an aluminum base, brass finger pieces and brass knobs for the wire connections. Very ingenious design and looks very impressive. I put it to the QSO test, but couldn't quite get used to the "feel". Still it is a fine example of what can be homebrewed, for those on a limited budget, who may not be able to afford a new "Begali".

Hollingsworth told the ARRL: "After about a year of thinking about the 'if not now, when?' question, I decided to retire January 3. I love working for the FCC and I've always had great jobs, but this one involving the Amateur Radio Service has been the most fun and I have enjoyed every day of it."

He continues, "For nine years I've worked with the best group of licensees on earth, enjoyed your support and tremendous FCC support and looked forward every day to coming to work. The Amateur Radio enforcement program will continue without missing a beat, and after retirement I look forward to being involved with Amateur Radio every way I can. I thank all of you for being so dedicated and conscientious, and for the encouragement you give us every day."

#### "What's My Sign?" by Julie McLain/KB8ZXR

I was born in Bay City, Michigan on April 9, 1965. When I was a boy, I was in the Big Brothers program, and my Big Brother was Del Wood, who was in his mid 70's. I credit him for my love of the outdoors, camping, and nature watching.

My wife, Laurie and I met in 1986 taking care of a gentleman who was a quadriplegic due to a motorcycle accident. One thing led to another and we were married in November of that year. We have three children—Amanda 18, Josh 5 and Michelle 9. Josh and Michelle have checked into the "Ladies Tea Time Net" several times and really enjoy talking "3rd party". My Mother, Beth (KD8GYN) became a Tech on September 8th and what a great feeling it is to have my Mom on the air with me! We nearly lost her to liver disease in 2004, but thank God she's still here to enjoy the Hobby and her family!

Years before I even thought about getting my Ham license, I was introduced to CB on my Grandfather's rig during the '70's and, thereafter, got involved in REACT and the Red Cross. I knew my uncle, Harold "Smokey" Chambers (KA8ONX-SK) was a Ham for many years, but rarely saw him operate, so I didn't get the "bug" then. However, when I moved to the Lansing area in the late '80's, I was invited to Field Day in Howell and it sparked my interest. After meeting Bill (KB8TTS), I was introduced to Don and Julie (KB8RAD/KB8ZXR) and fell in love with the Hobby after operating "3rd party" on Don's HT. My first HF contact was with the country's oldest living Ham, (Tex, W5BQU-SK) whom I worked 3rd party via Carl Canfield (K8YHH).

I got my Tech license in July '94 after testing in Corunna, and was among the last required to receive their license in the mail before operating. Years later, after several upgrades, I finally attained my 20 wpm in CW (it took SEVEN tries!), and reached Extra Class in 1999. Afterwards, I received VE accreditation and have served in my "home" VE Testing site of Corunna and in Lansing, as well. I call Corunna my "home", because those guys went out in a blinding snowstorm to find a third Extra Class VE so I could take my 20 wpm code test. Unfortunately, I missed it by one, then retested and missed it again. (I will never again abbreviate the word 'schedule'!).

After being so intimidated by the Code, I learned it and now LOVE a good CW rag chew. One item of interest is how I learned the Code. My Elmer, Ellis (W8YB) set up private classes at his shop in Lansing and he began to tell me a story about TOM EISH (look up the Code for that name) and that was the beginning! Ellis started the class by assuring me that we weren't there to "learn" anything! HA! I hope Ellis knows how grateful I am to him for all his help—he is my hero and good friend! As far as contesting is concerned, it isn't all that interesting to me right now, but I do love paper chasing.

In my shack I'm primarily running VHF/UHF right now. I have two Yaesu FT 2800's, a Yaesu FT 60R and an Icom IC-208H. My HF rig was recently purchased from the estate of Forrest Clark (N8PWD-SK) and I can't wait to get on the air with his rig—boy, do I miss him! My antennas include a TRAM 1481 dual-band vertical and soon to be added Cushcraft A3S and coaxial dipole for 10-80M. Plans for the coaxial are compliments of Bill (W8EB).

Amateur Radio has so many different areas of service to get involved with, and for me SKYWARN is my poison....my chocolate. I really get a thrill from storm chasing! Along with this and other opportunities for service, there are also a wide assortment of Amateur Radio Clubs you can join in this Hobby. A few that I really like and support are: CMARC, which is very special to me and my primary Club, along with the Second Class Operators and Flying Pigs QRP Club.

As far as my personal life, I drive truck for ACC, formerly GM Transportation. K8YHH was kind enough to get me an interview and the rest is history. As far as retirement, I can't wait to get there so I can spend more time on the radio and do my video stuff, which is my passion! I really love shooting Weddings, Family Reunions, etc. I've found it to be a creative outlet for me and if I ever get my business off the ground, I would like to do it full time.
