### Field Day 2015 Soapbox

We will remember this Field Day for a long time. Due mainly to the weather. Coldest, wettest FD WX I can remember. I was glad I came out on the Friday before to put some lines in the trees, while it was sunny and dry. I should have known we would arouse the wrath of our Ol' pal Murphy with the mere mention of Field Day. My very first shot at lofting an arrow to the upper limbs of a tree, hit the limb I wanted to go over, and fell to the ground. Was this part of some ancient Field Day CURSE? More determined than ever, I struck "pay dirt" with the second shot. Now that I had one line up, I thought about pulling two up in the same branch. Bad thought. I grabbed two new lines and spread them out. Then I forgot to tie them onto the main line! As I pulled up the main line, it seemed to be coming up to easy. I got a glimpse of the empty end of the line as it was being pulled out of reach. That sick feeling of stupidity and despair crept over me. Noooooo! After a few choice "greetings" to Murphy, I regained my composure. Nothing to do but start over. I did finally get some more lines up in the trees. But it sure didn't go as smoothly as some previous Field Days. I lost an arrow. Well maybe I wished I lost it. It hangs up about 60 feet in the air, silently laughing at me, taunting me, just dangling from the broken fishing line that keeps it a prisoner. Oh well perhaps I will find it next year. I attached the battery powered QRP rig to the coax and immediately heard an EA8 in the Canary Is.

Yes the "curtain" was indeed playing. I went home Friday evening with a good feeling about the antenna farm.

Saturday morning I awoke to rain showers. "Figures" I mumbled to myself as I looked at the dreary scene. The truck was all loaded up, so I filled up a "Cup o Joe" and headed out. A quick bite of lunch and we were awaiting the start. We had our QRP rig hooked up to the 20 meter Bruce Array and were going to take care of our "Solar power" Bonus points. At the starting bell, it was mayhem! Ahhh yes, the sweet sounds of Field Day! Chris NS8Q and I had discussed the "strategy" of staying on the QRP rig as long as the QSO rate was good.

We had our five qualifying QSO's in the first 7 minutes, so we just kept going. Got 13 Solar QSOs in 17 minutes before we swapped to the big rig. Proof you do not need high power to have fun! After a few runs up and down the band things got a bit harder. Slowly, in the late afternoon and early evening, the bands started to improve. Then they got downright good! We took turns doing "food shifts" until all of us were fed. Big thanks to Maribeth Harger for a super job organizing and serving up chow for the trenchermen! I think I gained weight again this Field Day!

The rain did let up finally to let Chris and I raise the 80m dipole for the late night gang. As night fell I grabbed another piece of pizza and headed off the relieve Ed, W8EO and first time FD attendee and new ham Teng Wu, KE8BII, who was trying his "fist" at the key to the surprise of us all. Ken Faiver W8HNI, had just arrived, and rates were slowing down on 20 so we made the switch to 40 meters. 40 was "WALL to WALL" signals with no room in between! Our "pruned n tuned" 40m dipole played great! I got my best rate of the contest. In one nice "run", I had 38 QSOs in 30 minutes. This stuff keeps us coming back for more! I was feeling fatigued (downright whooped) so I gave up the "hot seat" to Ken and wished them "Good Luck".

I got up early to a beautiful sunny Sunday morning! Now that is more like it. As I pulled in, I made my way to the food tent to "top off" my Joe. Several bites on a homemade cinnamon roll and I was ready for some more FD fun. I moseyed on over to the CW trailer and relived the night crew Ron, Bob, and Ken. Then mid-morning as Chris arrived, we went to 15 meters to try our luck. 15m was doing fine and padded our score well for about an hour or 2. When the rate on 15 slowed down, we switched to the big "curtain" on 20m again. I started in on 20m but my stamina was beginning to be kaput, so I relinguished the hot seat to Ken and Ron. They finished off the day in FB fashion. Then just when we had thought we had made it through Field Day with no more visits from "Murphy", Ken/KC8LTL decided to tempt fate as he lowered the "Bruce Array". Taking after me, he pulled up the wrong end of the line and our spool of rope sat 25 feet in the air. He was feeling rather "sheepish" about it but a big smile returned after the wind helped to blow it down within reach. Hi Hi Final tally 583 QSO's. A very FB effort by the CW crew. Thanks to all who participated in the fun.

My family had relocated here in 1967, and my Father ran the A&W root beer stand on Old Grand River and Ballard St. in the north end. Working at the root beer stand at a young age gave me some very fond memories of some of Lansing, Michigan's best days. In the 60's & 70's the Michigan School for the Blind was a worldrenowned training facility for the sightless. In fact, "little Stevie Wonder" lived right behind the A&W for a time, and was affectionately known to locals as "the blind boy from Ballard St.", was also a student there. As our conversation toured through Lansing in our memories, it was quite delightful to reminisce about some of our now gone businesses that were going strong back then. Companies like Knapp's, Howmet, Motor Wheel, Oldsmobile, Estes Furniture, Melling, Lindell, Wards, Grinnell's, Lansing Electric Motor, Wedemeyer's, Jim's Tiffany Place, Albert Pick, Casa Nova, Ramon's and of course, the A&W. Just to name a few. (Sigh) Lansing was in its "heyday" back then. Everyone had a job, and could afford to buy the goods we made here. Our economy was in high gear, and the world was at our fingertips! This was also when I first became a Ham. Happy times for me growing up in the Ol' north end. With great memories of a prosperous time in our city. All from answering a CQ from a ham far away. It is a small world, and Ham Radio spans those distances to make it even smaller. We said our 73's and wished each other well. I smiled to myself in the silent satisfaction of have been able to be here to see all the changes.

Ours is truly a wonderful hobby. It has thrilled and fascinated me for over 40 years, and continues to do so every time I turn on the radio. Here is to even more excitement the next time I turn on the rig. Where will my signals take me tomorrow?

I was born on August 27, 1977 in Lansing, Michigan, and have two younger sisters. We lived in Potterville for the first few years of my life and then moved to South Lansing, where we called home until I was in the second grade at Everett Elementary on Holmes Road. When they closed the school, my parents decided to move to Dimondale. In 1995, I graduated from Holt High School and enrolled in LCC's Architectural Technology/Residential Design program. Three years into LCC, I started working for Hausman Corporation, which has since been renamed to Harris Rebar. I have been working there for 17 years now. The first six years were spent in the Engineering Department, and the remaining 11 years with Estimating. Switching positions has opened up other opportunities for me within the company. One of which is to work more closely with our IT department. Because of this, I have started back to LCC to obtain an Associate Degree in Computer Network and Information Security.

My interest in radio began because my Mom stayed home with us kids, while my Dad worked. Occasionally, Mom would have to run errands, so she would drop us off at the Governor's Mansion in Lansing, where my Dad was stationed as one of four Michigan State Troopers. It was during my time there with him when he allowed me to listen to the police radios. When I got older, they bought me my first Radio Shack scanner. From then on, I was hooked! In my mid-teen years, two men introduced me to Ham Radio and became the first two Elmer's I would have in my "career" as a Ham. They were Doug Nelson AA8DQ (SK), a close family friend, and Harold Adams N8DXI (SK), Father-in-law to my Aunt. With their help and encouragement, I began studying and on September 30, 1995, I passed the Novice written exam. On December 9. 1995, I passed the Technician written exam, and became one of the "No-code" Techies, which no longer exist. It wasn't until January 25, 1997 that I passed the 5 wpm code test. I went on and upgraded to General, first by passing the 13 wpm on December 11, 1999, and then the written on April 8, 2000. CW has always been my favorite mode, and I learned mostly by listening to Morse Code tapes, but most of the CW education came from working with several of the club's veteran operators at Field Day. Among the several Ham's who saw potential and gave me opportunities to operate, were Bill Chapman W8TJQ (SK), Don Devendorf W8EGI (SK), Ken Faiver W8HNI, and Joe Denomme N8VYS. There is something about on-the-air operating that tapes can't provide, and with their help, I was able to quickly increase my speed. Before I could afford my own HF equipment, Field Day was the only chance I had to operate, and was something I looked forward to each and every summer.

The equipment I own has changed through the years, which is common with every Ham. I happen to have a wife who is a Ham, so the equipment listed is actually shared between us. As far as mobile radios, I own a Yaesu FT-8800R Dual-Band, a Kenwood TM-241A 2m, and a Yaesu FT-2800R 2m. The handhelds consist of a Yaesu VX-5 Dual-Band and a Motorola XPR-6500 for DMR Radio. As far as HF gear is concerned, I still operate a Yaesu FT-757GX2 with MFJ and LDG Electronics Tuners. For digital operations, I have a Signalink USB device. For operating CW, I have the following Keys: a Kent TP-1 Dual Paddle lambic, a Bencher BY-1, Vibroplex Single Lever, and my newest is a K8RA P-2 Paddle. For contesting at home, I use an external SCAF Filter, a Logikey CMOS 4 Keyer, and N1MM and N3FJP Software. The antennas consist of a Comet GP-1 Base Antenna, and a Carolina Windom Wire Antenna at 35-feet and covering 40-10m.

There, now that we've become a little better acquainted, "What's My Sign?" My Callsign is NS8Q and my name is Chris Ranes. My wife is Shannon/WA2NVK. I currently serve as a Director on the Board of CMARC, and am the new SCOPE Editor.

## FCC Goes Paperless The Amateur Radio Relay League VFC

In order to streamline procedures and save money, the FCC stopped routinely printing and mailing licenses in February.

There are a number of ways a license holder can obtain an official copy of their license. The official license will display the FCC logo and the watermark "Official Copy" will be printed across each page of an official authorization from FCC.

- 1. Download and Print License: The licensee can log into the FCC ULS License Manager System http://wireless.fcc.gov/uls/ with their FRN and password to 'Download the Electronic Authorization' of the official license. On the 'Download Authorizations' page the license holder will add their call sign to the 'Authorizations to Download' and then click download. The PDF of the license can be saved to a computer and printed later or the file can be opened and printed immediately.
- 2. Login and Set Paper Preferences: The licensee can log into the FCC ULS License Manager System http://wireless.fcc.gov/uls/ with their FRN and password and set their own paper authorization preferences for future mailings. This option determines whether a user will receive paper authorizations (printed license and FRN information) from the FCC. The license holder would select either YES or NO and then click SAVE. By selecting YES, you will continue to receive paper authorizations printed and mailed by the FCC. By selecting NO, you will not receive authorizations printed and mailed from the FCC. This preference will affect all granted authorizations on this FRN.
- 3. Receive License via email: When modifying, renewing or requesting a duplicate copy of the license, a licensee who already has an FCC Registration Number (FRN) and provides a valid e-mail address under "Applicant Information" while logged in to the ULS system will receive an official ULS-generated electronic authorization via e-mail.

The action of adding a valid e-mail address into the FCC system can also be performed by a VEC filing new, upgraded, modified or renewed licenses on behalf of applicants.

4. Contact FCC: Licensees may contact FCC Support via the web, by telephone (1-888 225-5322) or by mail to

request paper licenses. Please note that FCC recently stopped using distinctive paper stock to produce hard copy licenses and has been printing these on "standard, white recycled paper." The Bureau noted that the distinctive paper stock it had used was six times more expensive than the plain recycled paper it now uses.

All this information is located on the VE Resources page www.arrl.org/resources-for-ves in the section titled "Obtain a License Copy".

#### **Additional Information**

An unofficial "reference copy" can always be printed from the FCC's ULS License database http://wireless.fcc.gov/ uls/.

New licensees may choose to register their SSN (social security number) with the FCC and receive a FRN before the exam date to make retrieving a copy of their new license after the session much easier.

VE Teams may accept photocopies or printouts of licenses from the follow sources: the official license or reference license printed from the FCC website, and license data printed out from the ARRL website or QRZ website. This information can be found on the ARRL web page what to bring to an exam session.

# Amateur Radio Parity Act of 2015: 75 Cosponsors — and Climbing

The Amateur Radio Parity Act of 2015 -- H.R.1301 -- has been introduced in the US House of Representatives. The measure would direct the FCC to extend its rules relating to reasonable accommodation of Amateur Service communications to private land use restrictions. US Rep Adam Kinzinger (R-IL) introduced the bill on March 4 with 12 original co-sponsors from both sides of the aisle -- seven Republicans and five Democrats.

HR 1301 would require the FCC to amend its Part 97 Amateur Service rules to apply the three-part test of the PRB-1 federal pre-emption policy to include homeowners' association regulations and deed restrictions, often referred to as "covenants, conditions, and restrictions" (CC&Rs). At present, PRB-1 only applies to state and local zoning laws and ordinances. The FCC has been reluctant to extend the same legal protections to include such private landuse agreements without direction from Congress.

H.R. 1301 has been referred to the House Energy and Commerce Committee. Rep Greg Walden, W7EQI (R-OR), chairs that panel's Communications and Technology Subcommittee, which will consider the measure.

Michigan is fortunate to have 3 Congressmen who have signed on as co-sponsors: Representatives Benishek (1st District), Bishop (8th District) and Walburg (7th District). If one of these three are your representative, please go to their respective websites and send them a message thanking them for their co-sponsorship if you have not already done so.

Palmyra (KH5) ranks #9 on the Most Wanted List and #2 in Europe.

The Pacific Islands DXpedition Group has been awarded permission to activate Cooper Island in the Palmyra Atoll, 11-26, January 2016.

A team of highly experienced operators and veterans of many DXpeditions has been assembled. Team members include Craig K9CT, Lou N2TU, Jerry WB9Z, Tom ND2T, Mike K9NW, Ralph, KØIR, John K6MM, Bob, K4UEE, Hal W8HC, Dick W3OA, Jim N9TK, and Glenn, WØGJ.

The Team plans to operate five stations, 160 to 6 meters on CW, SSB and Digital modes, using a call sign to be announced at a later date. Antennas dedicated to working Europe will be deployed due to the high need and propagation path difficulty.

Critical to major DXpeditions are the immediate, up-front commitment costs. For instance, most of the equipment (antennas, coax, wire, connectors, and site material) has already been purchased, tested and shipped to Palmyra. These procurement and shipping costs are a significant portion of the overall DXpedition costs. It is estimated this DXpedition will incur costs of over \$200,000USD plus individual and personal expenses.

We are pleased we have received support from so many Foundations, Clubs and Individuals already. We are about \$30,000USD short of our need for the next payment November 1st. So please donate as soon as possible to help with the upfront costs.


