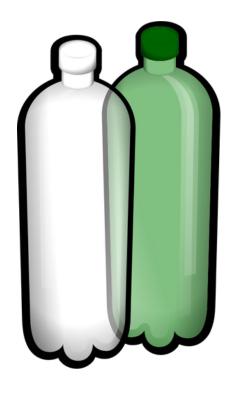

- 7. All nominations are to be closely checked and discussed by the Committee.
- If the Committee feels the nominees are not deserving, the award does not have to be given.
- 9. Nominations are to be submitted before **March 15th** of each year, so the Committee can make the selection and have the plaque engraved.
- 10. The recipient will be announced at the annual Ladies' Night.

# Portable Ops Florida - Part 3

# The continuing saga of a wandering QRP operator In this episode: The story of "Slingshot Slim."

fter two months of using my portable vertical setup, I was ready for something better. I have filled nearly three pages in the logbook, but the contacts were coming hard, and I missed many QSO's. Many of them could hear me but never getting my whole call. It was high time I remedied that situation with a better antenna.

I set my sights on the lone pine tree in the yard. In my "go kit," I had 75 feet of 22-gauge wire. The small gauge being primarily for stealth. With over 40 years of Field Days and many other portable ops under my belt, I'm quite accomplished at getting lines and antennas in trees. I prefer using a "bow narrow" for accuracy, but those items were too large to pack in the car. On this trip, I would use my trusty "wrist rocket." I rounded up the slingshot, sinkers, fishing line, and twine. A quick survey of the tree and surrounding area showed all clear. No eagles, gators, or other critters in the way. hee hee

I unwound a bunch of fishing line neatly so nothing would obstruct my sinker's flight. I got the sinker nestled in the breach, took aim, and let 'er fly. The first shot was a dud! Barely went 25 feet. It was evident that I had not used this method in a while. My 2nd shot had the height but missed the limb I was aiming for and lost a sinker in the process. No time or sinkers left for practice shots. I thought about my old pal Murphy, as I attached the last spare sinker, and hoped he would not show up today. The 3rd time was a "charm," as I lofted the line over one of the top branches. Soon I had some twine up high in the tree and attached one end of my antenna wire. The 22-gauge wire was almost invisible as I hoisted it upright to the top. I tied off the twine and carefully pulled the other end of the wire over the house. I did not want to beak it. The small gauge wire isn't very strong, but it's practically invisible. I don't know why I choose 75 feet of wire; it must have been what was left on the roll, but it was the perfect length. I attached a BNC connector

with an alligator clip at the corner of the porch. I tied a short piece of twine to the loose end and anchored it to a nearby palm tree. The top was up about 50-55 feet high, and the line sloped down at 45 degrees to the feed point right above the station location about 10 feet from the ground. I hastily connected the coax and ran inside to test it out.

My efforts proved very fruitful, as I powered up the rig and the speaker jumped to life with loud signals!

Now the big question. Would it load up? A quick run through the bands. 80, 40, 30, 15, and 10 meters all tuned up beautifully. Twenty meters had a 3 to one SWR, but I worked this out by adding a couple of feet of "counterpoise" wire on the bottom end.

It tuned correctly on 30 meters, so I gave it a try. I answered a "CQ" from 1-land. I was grinning ear to ear as I logged KM1CC, the Marconi Cape Cod ARC station. So far, so good. Then went on to work OH, NC, PA, and IN, all with good signal reports. It looks as though I had a winner. The real test was going to be in the upcoming NAQCC sprint.

I had only managed 4 QSOs in the last sprint, so I had high expectations of doing better now that I had an improved antenna.

On the eve of the sprint, I tuned up on 40 meters. Sure enough, I was not disappointed; my anticipation turned into "QRP joy" as I logged 15 QSOs on 40 and 80 meters in about 1½ hours during the January 21 sprint.

The next day, with a successful sprint under my belt, it was time to celebrate my good fortune with friends. The neighbors had happy hour, so I joined in and had a cold 807 and a few laughs. The XYL and I took the rest of the afternoon "off." We went to the beach in Venice, where we searched for sharks' teeth in the sand, had another "807", and relaxed as the sun went down.

"Tune in" next time for more "Monkey shines" and radio fun with your sojourning QRP operator. ■

# It's not a Begali, but....

ne of the questions I'm most frequently asked is, "What is a good paddle for a beginner?" My usual answer to this question is to look for a used Bencher BY-1 at a hamfest or on one of the online venues. You used to be able to get them for \$60 or less. Now, however, there are few hamfests and the price has gone up. Now, used Benchers are close to \$80.

Another option that newcomers might consider is the CW Morse paddle (shown in photo below). They cost \$60 with a steel base (\$43 without), and are available from 3rd Planet Solar and Gigaparts. I purchased one recently, and used it for a couple of days. To be honest, I was prepared to hate it, but it actually works pretty well. It's not a Begali, but it's good enough that I'd recommend it as a starter key.

These keys are mostly made from 3D-printed plastic parts. You can tell this from the finish. While not as bad as some 3D-printed parts, they do look a little rough. I wouldn't be surprised if they go to molded parts, though, at some point. In high volumes, it has to be cheaper to mold the parts rather than print them.


The key does have metal parts where it counts, though. The contacts are all brass, the base is made from 1/2-in. cold-rolled steel, and the levers pivot on sealed ball bearings. My key weighed 22.5 oz (1.4 lbs.), and was quite stationary on the silicone mat that I use for my keys. The Begali is, of course, a lot heavier at nearly 60 oz. (3.75 lbs.).

A spring between the levers provides the tension. Two screws allow you to adjust the contact spacing. Unlike the Begali, whose adjustment screws have a very fine thread to give you plenty of adjustability, these screws are standard thread screws. What this means is that it can be a bit tricky to set the contact spacing. The screws are springloaded to prevent the adjustment from changing, but the springs don't seem to be very beefy, and I can see where the adjustment might change after a lot of use.

The ball bearings give the key a nice action. During my tests, I had the speed cranked up to 23 wpm, and this key performed well at that speed. One thing I didn't like very much is that the arms tend to flex more than I like, but I actually have the same problem with the plastic Begali finger pieces. That's why I use the aluminum finger pieces on the Begali.

Overall, though, I'm quite happy with this key. And, for sixty bucks, which is about one-fifth of the price of a new Begali Magnetic Pro, I can certainly recommend this key to newcomers getting started in CW.

# Time to insure your ham radio gear?

n the Long Island CW Club mailing list, a fellow asked whether or not he should get insurance for his ham equipment. He writes, "Back when I ran a home brew 6CL6 tube type rig it didn't matter much. Now—the investment makes me think about the safety of the gear. Any suggestions?

One of the first responses was that the ARRL offers insurance. This insurance covers all of your equipment, including computers and costs \$1.40 per \$100 of equipment covered, with a minimum premium of \$20. There is a deductible, but it's only \$50. It covers equipment in your shack, theft from unattended vehicles, and towers and antennas up to \$15,000.00 replacement cost. Our club carries this insurance on our repeater system, and I know at least one club member carries it on his personal equipment.

Two of the folks replying to the original post have had good experiences with the ARRL insurance. One said, "About a dozen years ago lightening struck about a hundred feet from my home and took out 99% of the electronics including the hearing aids I was wearing. I didn't even notice the deductible after my insurance took care of everything. Just be sure you have a good agent!"

Another replied, "I am a big fan of the insurance available thru the ARRL. While some homeowner policies might cover gear in the house, the ARRL plan covers your mobile gear and portable gear as well. As I do a lot of mobile and portable HF and bring my gear on vacation even when traveling abroad, the ARRL plan is a good fit for me. And it covers full replacement cost."

Someone else mentioned that he had purchased insurance through Ham Radio Insurance Associates. This seems a bit more expensive than the ARRL insurance. There is a minimum annual premium of \$25 for \$1,600 of equipment coverage, but you don't have to be an ARRL member to get the insurance.

Should you get insurance? Well, the first thing you might do is to take stock of your gear to determine how valuable it is. Here's what one of the respondents had to say:

Once I did an inventory, my "shack" was more valuable than I thought – once I considered replacement value. My insurance agent told me that as long as it was a "hobby" that they would insure my equipment, but we have a \$500 deductible on our homeowner's insurance.

I was on the fence about specialty insurance until I heard the wind whistling past my 34' tower with gusts up to 70mph one winter night. I decided that if everything was intact by morning (it was) that I'd buy the ARRL insurance and be able to sleep much better at night.

I think that I'm long overdue on coming up with this list for myself. I'm definitely putting this on my ham radio to-do list. ■

# ARRL extends Field Day rules wavers, sets class D and E power limit

he COVID-19 pandemic-modified ARRL Field Day rules from 2020 will continue this June with the addition of a power limit imposed on Class D (Home Stations) and Class E (Home Stations-Emergency Power) participants. The news from the ARRL Board's Programs and Services Committee comes as many clubs and groups are starting preparations for Field Day in earnest. Field Day 2021 will take place June 26 – 27.

"This early decision should alleviate any hesitancy that radio clubs and individual Field Day participants may have with their planning for the event," said ARRL Contest Program Manager Paul Bourque, N1SFE.

#### **FOR FIELD DAY 2021:**

- Class D stations may work all other Field Day stations, including other Class D stations, for points. This year, however, Class D and Class E stations will be limited to 150 W PEP output.
- An aggregate club score will be published —
  just as it was done last year. The aggregate
  score will be a sum of all individual entries that
  attributed their score to that of a specific club.

ARRL Field Day is one of the biggest events on the amateur radio calendar. Last summer, a record 10,213 entries were received.



"With the greater flexibility afforded by the rules waivers, individuals and groups will still be able to participate in Field Day, while still staying within any public health recommendations and/or requirements," Bourque said.

The preferred method of submitting entries after Field Day is via the web applet. The ARRL Field Day rules include instructions on how to submit entries, which must be submitted or postmarked by Tuesday, July 27, 2021.

# Comm Academy: a FREE virtual training conference on emergency communications

omm Academy, the conference for EmComm and preparation, has been around since 2001, but this year, the event is online and free. The event, which normally takes place in Seattle is two days of training, talks, and information on emergency communications. Comm Academy 2021 will take place on April 10-11, 2021, and the theme for this year's event is "Disasters Here, There, and Everywhere—Are You Ready?"

According to Tim, WT1IM, the "PIO" for Comm Academy, the organizers are all volunteers who care deeply about EmComm and preparation, and want to create a forum for knowledge sharing. Until this year, CA was a local event in the Seattle area. While the attendees were enthusiastic, they were mostly local. That being said, the organizers realized that the 2021 conference gave them a "make lemonade out of lemons" opportunity to take what they were doing locally to a nationwide, if not global, audience.

This year's presenters come from a variety of backgrounds, but most if not all, are hams. For example, this year's lineup includes Tom Cox, VE6TOX, ICS Consultant for Alberta Emergency Management Agency; Jason Biermann, KI7KVP, Snohomish (WA) Department of Emergency Management Director; and Ward Silver, N0AX, who will present on station grounding and bonding. There will also



be presentations on providing Internet service restoration in a remote Oregon community after wildfires and safety and communications at Burning Man.

The presentations will all be pre-recorded, but the presenters will be on the conference live when their presentations are aired, so that they can do real-time Q&A, chat, etc., with the participants. - SURVEY: Dan Beuchert (WZ8MOJ) reported on the current responses to the Club Survey.
