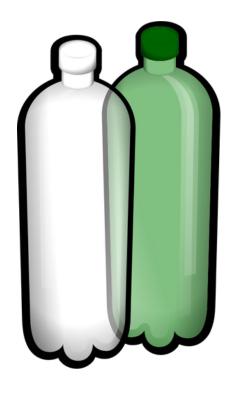

- 3. All nominations are to be kept secret until the award is presented.
- 4. All nominations are to be mailed (regular postal mail **OR** email).
- The same person can receive the award more than once.
- The Committee shall consist of the last three recipients; the senior member shall be the chairman.
- 7. All nominations are to be closely checked and discussed by the Committee.
- If the Committee feels the nominees are not deserving, the award does not have to be given.
- 9. Nominations are to be submitted before **March 15th** of each year, so the Committee can make the selection and have the plaque engraved.
- 10. The recipient will be announced at the annual Ladies' Night.

## CMARC ListServ

#### What is a mailing list and the ListServ?

A mailing list is a list of people's names and addresses used to send specific messages or announcements to many people at once, who are usually expected to share a common interest in the message's contents -- just like in the real world. However, unlike in the real world, you can usually join and leave the list as you see fit, so there is a good chance that you will actually find at least some of the messages interesting. Electronic mailing lists are more like clubs or magazines than a "real world" mailing list.

You may be familiar with the term "reflector," in which all postings are sent to all recipients in a discussion forum. In our case, the CMARC List is used to post only club-related announcements and general information about amateur radio. All postings are moderated.

The CMARC list is operated using the LISTSERV software. Postings to the list are archived for posterity. Access to the notebooks of archived postings is restricted to subscribers. You can search or browse through the archived postings and establish and manage your subscription using a web interface or email. Subscriptions are open, but new subscribers cannot post until vetted by a list administrator to prevent spamming. Non-subscribers cannot post at all.

#### I'm interested in receiving club information in this manner. How do I sign up?

There are two ways of signing up for the ListServ. The first way is by checking the box on your membership form stating you would like to be added to the ListServ. Our Membership Chairman will pass your name, call sign, and email address to one of our Administrators, and they will make sure they add you to the list.

You will find much more information about how to sign-up, how to post, where to search archived messages, etc.

To subscribe, create a blank email message and enter LISTSERV@lists.h-net.org as the message recipient. You do not need to add a subject. In the body of the message, you need to enter "subscribe," the mailing list name, "CMARC," then your first and last names. Follow this format.

#### subscribe CMARC John Doe

After the message is sent, you will receive an email confirmation. Please follow the instructions in the confirmation message to complete your subscription process. This prevents subscription spamming and typos.

#### I'm signed up now. How do I post a message of my own?

Create a new email message to the following email address: cmarc@lists.h-net.org

Your message will automatically be sent to our Moderators for approval. After approval, your message will be distributed to the list of subscribers.

## **Amazon Smile**

The CMARC Board has decided to take advantage of the Amazon Smile program. As long as you follow the directions below, whenever you make a qualified purchase on the Amazon platform, the club will receive 0.5% of the total amount you pay.

If you use the Amazon Shopping App on your favorite mobile phone, you need to make sure to turn AmazonSmile to **ON**. The setting is typically found in your settings, and a quick Google search will give you direction on how to set that for your individual phones.

#### **Desktop or Laptop**

1) If you are shopping on Amazon using a desktop or laptop, open your favorite internet browser, enter <a href="mailto:smile.amazon.com">smile.amazon.com</a>, then hit enter. Once the page loads, log into your account with your Amazon credentials.



2) Next, enter "Central Michigan Amateur Radio Club" in the search field, and click Search.



3) Next, click "Select."



4) Lastly, click the check-box and then click "Start Shopping."



## Portable Ops Florida - Part 4 The continuing saga of a wandering QRP operator



hat a difference a good antenna makes. My addition of the 75-foot long wire up in a pine tree is a big success. Many more QSOs in the log because of it. I'm still afraid that it may break in the breeze. After all, it's only a 22 gauge wire. The plus side is nobody can see it. I still can't get it to cooperate with me on 20 meters, though. I spent about 2 hours one afternoon adding and trimming different length stubs for the lower end. The best SWR I got for my troubles was 2.5 to I. Usable but not pretty! This also detuned my 30 and 80-meter match. I think I'm dealing with 2 problems on 20. The length of the wire (75 feet is a bit more than a full wavelength) and my feedline length. ( 30 ft is a bit under 1/4 wave on 20) So I put it back the way I started with about 3 feet of stub. You know the old saying, "If it works, don't mess with it." That was sound advice in this instance. I've decided to make a special attempt to work more on the WARC bands. I typically don't operate on the WARC bands from home due to a lack of resonate antennas and space. Now 80, 40, 30, 17, and 15 meters are all "happy." Right away, a nice improvement on the variety and strength of stations I was hearing. Plus, now they could hear me! 40 meters was open nicely to Europe on the eve of Jan 27, 2021. I listened in on the "gray line" at dusk and was happy to hear much of eastern Europe and some African stations. My best DX to date was the Caymans. Not exactly DX from here. But it was something other than the U.S.A. I wondered if they could hear me "across the pond" with just 5 watts? I threw my call into the pileups. I started out with Guadalupe in the Caribbean and then worked Serbia, Italy, Slovenia, and the Maderia Is. Also grabbed were several K<sub>3</sub>Y/XX stations for the SKCC anniversary and a Canadian to top it off. Worked some more K3Y/ XX boys the next day on 30 and 17. So I'm glad my new wire plays.

Next up, Winter Field Day.

I usually don't play in the Winter Field Day in Michigan due to the fridged temps. This was different. At 65-75 deg F, it was just like a regular Field Day. In order to play by the rules, I had to take down and reassemble my station over 30 feet away from the regular location. So I went for the carport on the other side of the house. I carefully pulled the antenna wire around the side of the carport

and anchored it off on the post. A quick test showed all was well. I wondered how my 5 watts would stack up in the heat of W.F.D. I jumped in right at the start and was doing OK. Just OK, I was only getting a good QSO every 5 mins or so. Many I had to work for. Yet some were nabbed on the 1st call. Very fun to work several in a row while moving up the band.

But for every easy one, there were several times where my 5 watts was only just above the noise on the other end. Also got pushed around by the "kilowatt boys" a few times. But that's what QRP contesting is all about. I concentrated mostly on 40M, a few on 20M. I paused for the night at dinner time, figuring I would try 80M in the morning and "clean up" working the west coast sections. I got up early the next day, connected the rig, and expected fun on 80. Up and down the band, nary a peep was heard. I went out to see if my antenna had blown down. Still up there. Looked as if Ol' Sol was making propagation interesting. Back to 40M, and after barely getting a few more in a few hours, I went Q.R.T.

Later in the day, glancing through the log, I brought up the states worked map and checked the stats.

The map shows just how strange the propagation was. Under "normal" conditions, I would expect to work many western states (C.A., AZ, TX, WA, etc.), but I didn't hear much west of the Mississippi River. Nearly all of the

signals were from the north. A "black hole" to the west. I had a good time at 5 watts competing with the higher power stations. Always amazes me what 5 watts and a wire will do. 64 QSOs with 27 sections in about 6 hours operating time.

One interesting observation was how many Ohio stations were operating from the outdoors! Wow! Those guys are tough! Must have had their Polar Long Johns on! The NAQCC sprint in February was another fun time. I topped the score of my last sprint, with 17 QSOs in 12 states on 40 meters. It's also interesting to "do the sprints" from a different Q.T.H. I work many of the usual suspects, But I also found it easy to work the Mich, Ohio, Indiana stations that I usually don't get a chance to work due to the skip zone from the Q.T.H in lower Mich.

There is also time for non-ham activities. The X.Y.L. and I packed up the bikes and rode the "Legacy Trail." It's an old rail trail that connected the Ringling Bros B & B circus to the main tracks and the rest of the country. That's how the circus animals came to all of America back in the '50s and '60s. You can almost hear the lions, zebras, elephants, and monkey chatter as you "ride the rails." It runs from Venice to the north through several parks and nature areas, to just south of Sarasota. We stopped at Osprey State park along the way to rest and have a picnic lunch. Flowers blooming everywhere. Thought this would be a good park for a Field Day operation. Plenty of trees and open areas. Several D.N.R. officers were trapping an unwanted alligator out of the

swimming pond. I talked with one of the Conservation Officers there about radio operations from the parks. He informed me that as long as I had a permit from the county parks department, a group operation like Field Day would be most welcome. The park routinely rents pavilions to youth groups, Scouts, etc.

A great way to spend a day enjoying the outdoors. Next up is the Cape Haze Trail.

While biking around the homefront, I ran into a "local" specializing in Comforting Head Massage. I couldn't resist trying one! Ahhhhh ........

Got over 5 pages in the log plus a bunch of contest QSOs. I may be able to gather enough contacts to obtain my next ranking soon. I still have time for another adventure before we head back north, so stay tuned for more next time. ■

## **Amazon to require FCC certification**

Here's an interesting notice from Amazon:

## Action required for radio frequency device listings on Amazon.com

This article was originally published February 1, 2021, and it has been adjusted to reflect a new estimated date for this change.

As part of our ongoing efforts to protect our customers and enhance the customer experience, Amazon is updating the requirements to offer radio frequency devices. This will affect some products you offer or have previously offered.

Starting in Q2 2021, in order to create new listings or update existing listings of radio frequency devices you will need to fill in the FCC Radio Frequency Emission Compliance attribute. In the attribute, you must do one of the following:

Provide evidence of Federal Communications Commission (FCC) authorization – either an FCC certification number or contact information for the Responsible Party, as defined by the FCC.

Certify that the product is exempt from FCC requirements.

As a reminder, per Amazon policy, all radio frequency devices must comply with FCC regulations and all applicable state and local laws, including registration and labeling requirements. Amazon also requires you to provide accurate information about your products on the product detail page.

You may not be aware that you are selling products the FCC considers radio frequency devices. The FCC broadly classifies as radio frequency devices any electronic or electrical product that is capable of emitting radio frequency energy. According to the FCC, almost all electronic or electrical products are capable of emitting radio frequency energy. Examples of products that are regulated by the FCC as radio frequency devices include, but are not limited to: Wi-Fi devices, Bluetooth devices, radios, broadcast transmitters, signal boosters, and devices with cellular technology. FCC guidance on what is considered a radio frequency device can be found on the Equipment Authorization – RF Device page on the FCC website.

We will follow-up with additional information, including a help page, closer to attribute launch.

For more information, see Amazon's Radio Frequency Devices policy. You can also bookmark this article for future reference.

Some are saying that this is an effort to control the sales of Baofengs. Others point to other radiators, such as LED lights and solar charge controllers. The reddit discussion of this new policy pretty much dismisses this new policy. One comment notes, "This has nothing at all to do with buying radios, it's just Amazon trying to cover their @\$\$es over the likes of 'Rugged radio'(and others) selling uncertified radios as something they're not."

I think that this could be interesting if Amazon really got serious about this. I'm not sure that even Amazon has the wherewithal to really do this kind of policing, though.

#### Call to Order

• The meeting began at 7:06pm. In the absence of President Gordy Smith (KE8JKS), Vice-President Dan Dembinski (KD8YDE) chaired the meeting.

#### **Club Business**

- Dan Beuchert (WX8MOJ) spoke to Kevin regarding the sale of the clubhouse building; there was no new info. He shared that he has informed Kevin of our 501(c)(3) status for tax purposes, which Kevin was very happy to hear about, and that this status may give prospective buyers incentive to not evict the Club if the building sells.
- Chris Ranes (NS8Q) stated he was just about finished with the current SCOPE issue with updated membership forms. He hoped to have it out over the weekend.
- Gregg Mulder (WB8LZG) brought up the SK donation, given the current financial situation. Discussion ensued regarding discontinuing the \$40 donation and/or sending flowers for the time being, until the Club's finances improve. Several former Treasurers spoke on the issue, in favor of reducing or eliminating the donation. It was moved by Don McLain, supported by Gregg Mulder, to temporarily discontinue the cash donations or flower purchases for the time being. The motion passed.
- Dan Beuchert (WX8MOJ) spoke about the results of the recent CMARC survey. He shared the raw data with the Board, which gave us a lot of input regarding areas of interest and support. - John Doornhaag (KD8NNQ) spoke about dues payments late in the year, and the practice of giving members credit for an extra year if they paid in the fourth quarter. It is a financial burden that the Club cannot support, even in normal times, and trying to track mid-year payments would be unworkable. Further discussion ensued. It was moved by Secretary Vick, supported by Don McLain, to eliminate the practice of awarding a free years' membership to anyone who renews in the last guarter of the year. The motion carried.

- Discussion also took place on the practice of giving a new licensee a free membership. Many new hams are waiting three to four months or longer after passing their new Tech License test before applying. The Board decided to limit the free memberships to those who submit an application within thirty (30) days of getting their license, and limit the free membership to the calendar year – Secretary Vick noted that club membership was for "the calendar year, and not necessarily for twelve months". Chris Ranes screen-shared to show the edits he made to the Membership Application, reflecting those changes.
- Dan Beuchert (WX8MOJ) spoke about the Training Nets. The first ARPSC Training Net on 145.390 had 18 check-ins, and the first ARPSC training Zoom session had 27 attendees. The first CMARC Training net on 145.390 had over 20 check-ins. Gregg Mulder (WB8LZG) spoke about listening remotely to the training nets and the SSTV net from Florida. He said the nets are going to be a good driver for increased club membership and participation in the future.
