

Out West Portable 2021

t had been over 2 years since our last visit to see the kids in California, so my XYL and I packed up the pickup truck and trailer before Thanksgiving and headed for the west coast. Driving out west was an adventure all its own. We stopped in several small towns to rest and see the local sights along the way. I couldn't resist a picture of this caboose in Missouri. A great logo on the gondola. They must have been using "Spark" to send messages.

We arrived in southern Cal. the day before the holiday to nice warm weather. Perfect for assembling the ham gear. My rig of choice for portable operations was the Yaesu FT-817. I've used this radio for portable ops for many years now, and it has proven itself a very capable rig for this purpose. The kids live in the desert on the edge of the Sequoia National Forest. I was looking forward to some great fun running QRP from this new QTH out in the high desert, Field Day style.



So, while they were cooking the Thanksgiving dinner, I was busy assembling the ham station in the trailer. I had tested all of the ham gear before leaving, and now was the actual test.

I pulled out the "Phoenix Vertical" and extended it to the proper length. (see Dec. 2021 NAQCC newsletter) Making sure all the clamps were tight, I hoisted it up to the top of the ladder rack in the trailer and secured it on the mount. Then I spent the next 20 minutes spreading out the radials. My radial pack has 6 wires for 20 meters, 6 for 40 meters, and a couple extra for 80 and 15.

Extra care was taken when laying them out to ensure none of the other family members tripped or "hung" themselves on all the wire. I plugged in the coax and power to the rig and was rewarded with many signals as I switched on the radio. Oh boy! A quick check of the SWR on 20 and 40 showed all was playing nicely. I even had a nice match on the 18 Mcs band. Icing on the cake! Just then, the chow bell rang. Looks as though I'd have to wait until after the family meal.

Later in the afternoon, I snuck off to the trailer with a full belly to see if my lashup would produce some good results.

I had just applied for and was granted a new callsign, W8GG, so after nearly 50 years as WB8LZG, I was anxious to give the new call a try. My 1st QSO was with N9JF, Jim, in Illinois on 18 Mcs. (that's where I had left the dial) We had a good solid QSO, and then I switched to 20 meters to see what I could raise there. I had a very nice rag chew with Cecil, K5YQF, in Texas, who was also a trailer traveler. Small world.

Then I listened around to see if I could snag any DX. Sure enough, I answered CQ's from 2 different Japanese stations, both giving me good signal reports. Yes, the new skyhook was indeed working!

The next evening right before the CQWW contest, I answered a CQ from Hawaii and smiled in satisfaction as he came right back to me. Oregon also made it into the log on 40 meters before going QRT for the night. I had thought about getting on the air for the CQWW contest, but family obligations kept me from the radio for the rest of the weekend. All too soon, it was "tear down" time. The radials were wound up, the vertical taken down and collapsed, ready for the next temporary QTH. Next stop, Arizona!

We were going to stay in Lake Havasu, Arizona, but the state park was full. This turned out to be advantageous for us as we continued south and found a great location at Cattail Cove state park. This park was very quiet and very beautiful. The only trouble was that it was in a very DEEP canyon with mountains on all sides. A real challenge for radio propagation. We were "Off the Grid." This meant no TV, internet, Cell Phone, radio, and contact with the outside world, except for ham radio. This also proved to be a refreshing relief from the "same old news" every day on the TV and FM radio. As I assembled the antenna and radials, I wondered if I'd have any success at all getting a QRP signal out from down in the canyon. I wanted to set up my 20-meter dipole, but park rules forbid the use of the trees. I did ask the rangers for permission to lay out my radials. So up went the vertical, yet I was skeptical about my odds for any radio contacts. Conquering the high canyon walls would take all the juice I could get.

I figured that I might need a bit more power to "get out" through the tall canyon walls. I found a local Power Plant at Parker Dam, AZ. to hook into to supplement my FT-817 output. That night I snuck out of camp and secretly plugged in my 2-mile long 12v power cord to the "mains." The only problem was, every time I went "key down," Lake Havasu, Barstow, and half of Las Vegas all experienced blackouts on the electric grid. Hee Hee.

We stayed a few more days there; however, there was no more time for radio ops, as we were busy hiking the trails and taking in the beauty of the canyonlands. The trip's next leg took us to the Petrified Forest National Park. This looked like it would be a great place to set up the rig; however, we spent all of our time exploring the park. No time for radio. (oh, the shame)



In short, we had a wonderful trip visiting family and touring the countryside together. Stay tuned for more adventures in 2022, as we plan to go south sometime during the winter to escape the cold.



Local HAM and Army Reservist Tom Horton, KD2GVS, was informed late September that his reserve unit had been one of four companies selected to pull volunteers for a deployment within the continental United States. The mission: aiding, supplying, transporting, and relocating refugees that just recently arrived from Afghanistan. Six major installations house the refugees, including Camp Atterbury, Indiana and Ft. Pickett, Virginia.

SPC Horton, whose promotion board to Sergeant is just around the corner, heard the odds of him getting selected were roughly 1 in 16. He didn't like those odds, so he volunteered. Horton will now mobilize before the end of October, heading north for a one-year deployment. He and his new company are likely to specialize in transporting refugees to resource centers, health providers, and aiding in relocating them to permanent homes. Horton will resume his surfing of the radio waves when he returns late fall of 2022.

Tell operators when they're off frequency

ams can sometimes be hesitant to notify others when their signal isn't quite up to snuff or when they're off frequency. After a recent contact, I've decided that I'm always going to mention this to someone that I'm in contact with.


What happened is that a station answered my CQ, but he was so far off frequency that I missed his first call. I could see him answer me on the waterfall, but he was outside my passband, which was set to 250 Hz, so I couldn't hear him. I set my RIT so that I could hear him and sent QRZ?, and when he replied to that I picked him up just fine.

We went through the RST/QTH/name first exchanges, and on my second transmission, I mentioned that he was transmitting about 500 Hz below my frequency. When it was his turn, he thanked me for mentioning that, and said that he was wondering why CQing stations never seemed to hear him. He spent the next couple of transmissions zeroing in on my frequency. Hopefully, he'll now be heard by stations he's calling.

Of course, if I'd had my passband set wider, I would have heard him on his first call. That's my bad, but he will have better success if he zero beats the station he's calling in the first place.

Working DX on 30m during the contest

A week and a half ago, during the CQ WW CW contest, I got on 30 meters, not wishing to throw myself into the pileups on 20 meters or 40 meters. I was pleasantly surprised to find the 7P8RU DXpedition to Lesotho. And,



since all the other CW ops were working the contest, they weren't getting many takers. I was able to work them on the third call.

After working 7P8RU, I looked around a bit and happened upon the HD8R DXpedition to the Galapagos Islands. I got them on the first call! I already had HD8 in the log, but 7P8 is a new one for me.

Repeater crawl

They guys here in Southeast Michigan do an amusing thing called the Repeater Crawl. On the first Friday of every month, a group of operators congregate on the General Motors repeater on 443.075 MHz (123Hz PL), which has the best coverage of any repeater in the Detroit area and then set out to see how many of the other repeaters the folks in the group can hit.

I happened to be in the shack with my VHF/UHF radio on when they turned their antennas towards Ann Arbor. I was hoping that they'd call for local checkins, but was disappointed when they did not.

In any event, I think that this is a great activity. If you live in an area with several repeaters, you should consider setting up a "crawl" where you live. ■

Getting hooked up to Reverse Beacon

love the Reverse Beacon Network (RBN) and have often thought about becoming one of the spotters in order to give something back. One of the things holding me back was that I needed to install CW Skimmer. Last December, I tried to get CW Skimmer working with my Flex 6400. Unfortunately, I wasn't successful, and being both impatient and ambivalent about paying \$75 for the program, I gave up on it after a little while.


A couple of weeks ago, I decided to try it again. This time, after consulting the Flex Radio Community Forum, I was successful. The trick getting a program called Slice Master 6000, which configures and launches third party applications, such as CW Skimmer, GRITTY, WSJT-X, and flDigi, automatically. (By the way, it's called Slice Master because Flex refers to their receivers as "slices.")

With that program up and running, the next step—and it turned out to be a bigggg step—was to connect CW Skimmer to RBN. The first thing that you have to do is to find the right version of a program called Aggregator. Unfortunately, there are links on the RBN website to version 4.4, and that's the version I first downloaded and installed. So, of course, that didn't work.

The version that you want is version 6.3. Honestly, I've forgotten how I found the right version, but you can find it at http://www.reversebeacon.net/pages/Aggregator+34.

After installing version 6.3, I was able to get Aggregator to connect to and collect spots from CW Skimmer, but it still wasn't connecting to RBN for some reason. Googling around, I found the RBN-OPS groups.io mailing list. I asked for some help there, and after checking some of the obvious things, one of the fellows volunteered to actually log in remotely to my computer and get it all sorted out.

We spent nearly two hours debugging the problem, and honestly, I'm not sure what all he did, but it's now up and running. At this point, I'm only spotting on one band at a time, and only when I'm not operating, but at least I'm giving something back to RBN.



It's been quite interesting to watch the spots. Here's a screen shot from a couple of mornings ago:

I'm not sure the ZMIA spot is for real. I just didn't have enough time to run down there and try to work him. It is very interesting, though, to see how propagation changes throughout the day.

One thing that I found out is that many, if not most of the spotters are using Red Pitaya SDRs and not regular amateur radio transceivers. The Red Pitayas have an incredible bandwidth, and that's why you see so many of the spotters providing spots on so many bands.

When my helper found out that I was using a Flex to provide the spots, he made it sound as though my single-band or dual-band spots weren't going to be all that useful. It may not be as useful to the network as all the other spotters, but it certainly is interesting to me.

He also bristled when I suggested that the Aggregator documentation could be improved and that there might be more RBN spotters if the documentation was better. His position was that the really serious folks would persist and get it up and running. I'm not so sure about that. I think a lot of people give up when they encounter poor documentation.

Anyway, looking to the future, I think my next step is to be setting up my Flex 6400 to listen on two bands and send those spots in. After that, I may think about getting a Red Pitaya to become a more comprehensive spotter. The Red Pitayas cost \$500, though, so it's not an insignificant investment.

Lansing Amateur Radio Public Service Corp (ARPSC) **Meeting Minutes**

Monday, September 20, 2021

- There have been three Amateur Television (ATV) Deployments in support of Lansing EM (Jeff Goeke-Smith)
 - Two were in Riverfront Park
 - One at Jackson Field
 - There are NO wired cameras at Jackson Field, so we are the best cameras Lansing EM has at the moment
 - All deployments used 3 cameras two remote and one local at command
 - o The cameras provided better picture of the events than the naked eye in low light conditions
 - Two TVs at the EOC at FS1 have failed
 - These TVs showed video feeds from ATV streams
 - These will be replaced with a single 4K monitor
 - Might end up with more 4K cameras in the future
 - Jeff noted that systems are being packed fully assembled for quicker deployment
 - Camera mounts have been moved down so two brackets could be put on pole
 - o 3GHz is going away as well as those access points need to look into 5.8GHz to replace them
- October 9th Statewide Emergency Test
 - Setup looks to be similar to the last one
 - Stations will be setup throughout the county to receive messages from other counties
 - Could try to send / originate more messages
 - Planning information will be uploaded to Basecamp
- November 19th Silver Bells
 - Currently have 9 volunteers and plan to setup three cameras
- Skywarn Updates
 - We have had a few Skywarn net activations this summer
 - Some events happened too guickly to start a net before storms were out of the county - or - we had difficulty getting a Net Control Operator (NCO) to star the net due to conflicts or timing (i.e., during workday)
 - We currently have scheduled people on call to watch the weather and decide if a net is needed, but do not have scheduled primary NCOs
 - There were volunteers for being trained for NCO and being on call NCO during the day
 - There was discussion to have a committee look at
 - Updating the SOG
 - Formalize new NCO training
- MICIMS users: Make sure that you log in for annual verification and take any practice modules that have been referenced in emails

- Basecamp Application
 - Jeff is proposing that we do more operational project management within Basecamp
 - There was feedback on getting some more training on Basecamp, how to customize notifications, and it was given
 - There are plans to create or link to some tutorial material for new users
 - There was some talk about the cost of this program
 - Jeff has been using the free program, but is willing to and has purchased use of the full version
 - Consensus was that using Basecamp did help to organize events and we will trial using it in more activations to test it out further
- LCDRA Presentation from Jeff Goeke-Smith KC8PUN
 - Jeff went through his presentation about LCDRA's current status and goals
 - Described the chance to move from current Eaton County tower at Potterville to the WKAR tower in Okemos to increase the footprint of the repeater
 - Rough Potterville math: Current 200' height leads to a 20-mile horizon
 - Rough WKAR math: roughly 600' location at WKAR tower would lead closer to a 35-mile horizon
 - Dennis ZQZ shared some thoughts and information about LCDRA and costs too
 - LCDRA used to keep 10k in the bank and have 200+ members
 - Feedline \$2/3 per foot, connectors at \$100, antennas at hundreds, duplexers are hundreds, tower climbers are a few thousand, insurance \$300/yr., new repeater \$2-3000
- Training Net on 9-13-21
 - Last net was a review of deployments, update on Skywarn procedures, etc.
 - Had 12 check ins, plus NC, plus 3 +1s and went nearly 40 minutes
 - We are always looking for new topics for training and new NCOs
 - NO net control experience is needed to volunteer, we'll train!
 - NO membership in our group is needed to check into our net!

 - o Daniel Beuchert WX8MOJ was elected as President, and Jim Hannahs KC8QWH was elected as a Director because of the retirement of John Imeson N8JI (effective 1-1-2022).

- Status Updates on LCDRA Repeaters:
 - 145.39 located on Eaton County's Potterville tower:
 - The 145.390 repeater location challenge continues with the impending retirement of John Imeson from Eaton County. LCDRA continues to attempt to find a new long-term home for the repeater. The WKAR site, while available, continues to be a problem because of the long-term funding situation. Alternate repeater sites are being investigated that may be more compatible with LCDRA's cash flows.
 - Repeaters at McLaren Greater Lansing Medical Center:
 - McLaren has indicated that they may be repurposing the building at Greenlawn, where the 146.940, 146.700, and 224.980 repeaters are located, so at this time, there is no immediate need to move the repeaters. LCDRA is evaluating moving one or more of the repeaters to alternate sites to gain physical separation for the 2m repeaters and/or add significant coverage to the 220 repeater.
 - As always, LCDRA looks to be of service to the community. Some problem reports were collected during the meeting that implied a bigger, more broad issue. Resources were identified to investigate, and that work is ongoing. If you have problems or note issues, please feel free to contact LCDRA at contact@lcdra.net.
- Membership chair update from Michael Boensch W8MKB shows that there were 4 additional membership applications in August and 6 additional by the November meeting, so it seems that there has been some increase in membership after Jeff Goeke-Smith KC8PUN's talks at Hamfest and CMARC.
